#### 3.1 Conventions

The formal notation convention used in sections 8 and 9 to formally express the structure and internal dependencies between specifications in the Enabler Release specification baseline is detailed in [SCRRULES].

**Enabler Release** Collection of specifications that combined together form an enabler for a service area, e.g. a download

enabler, a browsing enabler, a messaging enabler, a location enabler, etc. The specifications that are

forming an enabler should combined fulfil a number of related market requirements.

#### 4. Release Version Overview

Mobile devices are becoming more and more advanced with many features, such as Cameras, Bluetooth, USB, keyboard, peripheral and more. In many circumstances Enterprises, regulations and others have policies against the usage of some features but allow the use of other features available on mobile devices. Therefore there is a need for selectively enabling and disabling device capabilities.

The DCMO enabler targets to specify the mechanisms required for the remote management of device capabilities. In particular it will address the ability of remote enablement and disablement of device capabilities. The device capability information will be exposed by DCMO to facilitate management of the Device Capabilities. The DCMO enabler also specifies the mechanisms to convey the result of DCMO Operations or report the discovery of new device capability.

#### 4.1 Version 1.0 Functionality

The DCMO Enable V1.0 introduced following functionalities:

- Support a mechanism to enable of the Device Capabilities
- Support a mechanism to diable of the Device Capabilities
- Support a mechanism to specify whether the end-user is informed of DCMO operations performed in the Device.
- Support a mechanism to indicate whether the user is allowed to enable or disable specific Device Capabilities
- Support a mechanism to expose the Device Capabilities via management tree
- Support a mechanism to indicate whether a Device Capability is removable and whether it is currently attached
- Support a mechanism to report the result of DCMO Operations to DCMO Server
