4. Introduction

This document defines the technical framework and specifies mechanisms to enable services based on the MSF requirement document [OMA-MSrchFramework-RD] and the MSF architecture document [OMA-MSrchFramework-AD].

- Section 6 defines that behaviour of different entities on receiving/sending particular response/request.
- Section 7 provides the protocol bindings for all the messages defined.
- Section 8 defines that data model consisting of Data types, commonly used parameters and structures, XML schema etc.
- Appendix C provides a couple of methods, following the specification, for SE selection.
- Appendix D provides User Interest Model.
- Appendix E provides message examples.




Figure 1: QueryCapabilities messages exchange




Figure 4: Flow for Subscribe Request and its response




Figure 5: Flow for Feedback Request and its response




Figure 6: Flow for Next Page Request and its response








Figure 8: Flow for QARequest forward and its response





Figure 9: Flow for Feedback Request forward and its response



5.4.1 SE and MSS Registration

MSrchFramework enabler enables SE and MSS to register with it using this interface. This registration is required for fulfilling various requirements including SE selection, request transformation. In this registration process, SE and MSS submit their basic information (RegistrationRequest) to the MSS, which responses back (RegistrationResponse) with the unique Provider-ID.

This message can also be used to update registration information.

5.4.2 Meta-Index Submission

Once the SE or MSS is registered, it submits its Meta-Index (SubmitMeta-Index) to MSS. The Meta-Index consists of terms and Search Domain statistics. Term statistics aims to provide Term Frequency, for all the terms, across all the documents. Whereas, Search Domain statistics aims to provide Domain Relevance of all the documents in the SE's database. The main purpose of Meta-Index is to provide enough information about the SE, so that an appropriate SE can be selected for a particular request. The following message can also be used to update meta-index.




Figure 11: Questions Retrieve




Figure 12: Search dispatch Interaction




Figure 13: Question & Answer Dispatch




Figure 14: Personalized Search Interaction

5.6 MSF-5

5.6.1 Notify

MSAS uses MSF-5 interface to return the results for a subscription made using SubscribeRequest on MSF-1. The NotifyRequest message is defined for this purpose.

5.6.1.1 NotifyRequest

The NotifyRequest message SHALL be formatted similarly to SearchResponse message defined in 5.2.2.2 with the following clarification: the feed id (also referred to as "Request-ID" feed schema item) SHALL contain the value of the Subscription-ID provided to the MSF-Client in the SubscribeConfirmation message of the related subscription.

6. Architectural Entities definition

6.1 MSF-Client Functionalities

When sending requests on MSF-1 interface, MSF-Client MAY insert user authentication and authorization information. If challenged by MSAS, it SHALL insert user authentication and authorization information in the request.

In order to configure the target MSAS to which MSF-Client sends requests on MSF-1, a Management Object for MSF-Client configuration is defined in [MSFCC MO-TS]. The MSFCC MO consists of a list of MSAS entries; each of them containing a list of related configuration parameters.

If the MSFCC MO is provisioned on the terminal, then the MSF-Client MUST use the value of the ClientID provisioned in the MSFCC MO as Client-ID parameter when sending requests on MSF-1 interface, as specified in [MSFCC MO-TS].

6.1.1 Q&A request

To send a Q&A request to MSAS MSF-Client SHALL perform the following steps:

- MSF-Client SHALL create a request using QARequest message.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL select one of the MSAS entries, which matches all of the following conditions:
 - The MSAS entry supports the "Q&A" value as SearchFunction.
 - o A DomainName of this MSAS entry matches the "QAField" parameter of the QARequest if present.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL use the information contained in the entry of the selected MSAS using the procedures below:
 - If a "Language" entry is provisioned, MSF-Client MUST delete any existing "language" parameter in the QARequest message and insert the entry value.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL send the QARequest to the URL entry of the selected MSAS.

6.1.2 Subscribe request

To subscribe, MSF-Client SHALL perform the following steps:

- MSF-Client SHALL create a subscribe request using SubscribeRequest message.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL check the SubscriptionDuration entry in the MSFCC MO. If provisioned, MSF-Client SHALL include the value of the SubscriptionDuration entry as "Duration" parameter in the SubscribeRequest.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL select one of the MSAS entries, which matches all of the following conditions:
 - o The MSAS entry supports the "Subscribe-Push" value as SearchFunction.
 - The MSAS entry supports the "Recommendation" value as SearchFunction if the SubscribeRequest contains at least one "RecommendationAl" parameter.
 - The MSAS entry supports the "Multimedia" value as SearchFunction if the SubscribeRequest contains a "Content" or "Content_URL" parameter.
 - The MSAS entry supports the "Free-text" value as SearchFunction if the SubscribeRequest contains a "searchTerms" parameter.

- The MSAS entry supports the "byKeyword" value as SearchFunction if the SubscribeRequest contains a "Tags" parameter.
- A DomainName of this MSAS entry matches the "Domain-Name" parameter of the SubscribeRequest if present.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL use the information contained in the entry of the selected MSAS using the procedures below:
 - If a "Language" entry is provisioned, MSF-Client MUST delete any existing "language" parameter in the SubscribeRequest message and insert the entry value.
 - If a "ContentFilter" entry is provisioned, MSF-Client MUST delete any existing "contentFilter" parameter in the SubscribeRequest message and insert the entry value.
 - If a list of "Site" entries is provisioned, MSF-Client MUST delete all existing "site" parameters in the SubscribeRequest message and insert the entry values.
 - If a list of "RecAlg" entries is provisioned, MSF-Client MUST delete all existing "RecommendationAl" parameters in the SubscribeRequest message and insert the entry values.
- If the MSFCC MO is provisioned on the terminal, MSF-Client SHALL send the SubscribeRequest to the URL entry of the selected MSAS.

6.1.3 Search request

To send a search request, MSF-Client SHALL perform the following steps:

- MSF-Client SHALL create a search request using SearchRequest message.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL select one of the MSAS entries, which matches all of the following conditions
 - The MSAS entry supports the "Subscribe-Push" value as SearchFunction if the SearchRequest contains a "Receiver-ID" parameter
 - The MSAS entry supports the "Recommendation" value as SearchFunction if the SearchRequest contains at least one "RecommendationAl" parameter
 - The MSAS entry supports the "Multimedia" value as SearchFunction if the SearchRequest contains a "Content" or "Content_URL" parameter
 - The MSAS entry supports the "Free-text" value as SearchFunction if the SearchRequest contains a "searchTerms" parameter
 - The MSAS entry supports the "byKeyword" value as SearchFunction if the SearchRequest contains a "Tags" parameter
 - A DomainName of this MSAS entry matches the "Domain-Name" parameter of the SearchRequest if present.
- If the MSFCC MO is provisioned on the terminal, then the MSF-Client SHALL use the information contained in the entry of the selected MSAS using the procedures below:
 - If a "Language" entry is provisioned, MSF-Client MUST delete any existing "language" parameter in the SearchRequest message and insert the entry value
 - If a "ContentFilter" entry is provisioned, MSF-Client MUST delete any existing "contentFilter" parameter in the SearchRequest message and insert the entry value

- If a list of "Site" entries is provisioned, MSF-Client MUST delete all existing "site" parameters in the SearchRequest message and insert the entry values
- If a list of "RecAlg" entries is provisioned, MSF-Client MUST delete all existing "RecommendationAl" parameters in the SearchRequest message and insert the entry values
- If the MSFCC MO is provisioned on the terminal, MSF-Client SHALL send the SearchRequest to the URL entry of the selected MSAS.

6.1.4 NextPage request

To request for next set of results/answers, MSF-Client SHALL perform the following steps:

 MSF-Client SHALL send a request using NextPageRequest message to the same MSAS than the related SearchRequest or QARequest.

6.1.5 Feedback request

After receiving responses containing results or answers (from search, subscribe and Q&A) the MSF-Client MAY send to MSAS a FeedbackRequest message containing the indication of the interaction performed by the user over a result. The target MSAS for the FeedbackRequest SHALL be the same MSAS than the related SearchRequest, SubscribeRequest or QARequest.

If the user feedback corresponds to an explicit vote, rating, comment or review action, then the MSF-Client SHALL include in the FeedbackRequest at least one of "vote" or "comment" parameters. In addition the "taglist" parameter MAY be specified.

If the user feedback corresponds to a click on a link related to a result or answer, then the MSF-Client SHALL include in the FeedbackRequest an "action" parameter with "click" as value.

If the user feedback corresponds to bookmark action on a link related to a result or answer, then the MSF-Client SHALL include in the FeedbackRequest an "action" parameter with "bookmark" as value.

6.1.6 QueryCapabilities request

To send a query capabilities request MSF-Client SHALL perform the following steps:

• MSF-Client SHALL send a query capabilities request to an MSAS using QueryCapabilitiesRequest message.

6.2 MSAS Functionalities

When receiving requests on MSF-1 interface, MSAS MAY require user authentication and authorization information and challenge the MSF-Client

6.2.1 QueryCapabilities Handling

When receiving a QueryCapabilitiesRequest message on MSF-1 interface,

- The MSAS SHALL read the list of "CapabilityName" requested.
- For each "CapabilityName" requested,
 - o it SHALL check whether the capability is supported
 - o if the capability is supported:
 - When "SearchFunctionality" is requested, the MSAS SHALL retrieve the list of search functionalities currently enabled
 - When "RecommendationAlg" is requested, the MSAS SHALL check if the SearchFunctionality "Recommendation" is currently enabled and then SHALL retrieve the list of recommendation

algorithm(s) supported.

- When "InputType" is requested, the MSAS SHALL check if the SearchFunctionality "Multimedia" is currently enabled and then SHALL retrieve the list of MIME type(s) supported.
- When "SearchDomain" is requested, the MSAS SHALL retrieve the list of search domain names supported.
- When "PerformancePar" is requested, the MSAS SHALL retrieve the information related to the performance parameter requested in the PerformancePar structure.
- instead, if the capability is not supported, it SHALL return the indication that the capability is not supported.
- o it SHALL include the retrieved information, about the capabilities requested, in the QueryCapabilitiesResponse according to format supported on MSF-1.
- The MSAS SHALL send back the QueryCapabilitiesResponse to the requesting MSF-Client.

6.2.2 Search Request Handling

On receiving a search request from MSF-Client on MSF-1 MSAS SHALL perform the following steps.

- MSAS SHALL generate User Interest Model. What should constitute UIM is described in section 8.2.2. The UIM is formed by performing data mining in user profile, Search History, Feedback/Interaction, etc. The exact formation mechanism is considered out-of-scope and left for implementations.
- If a Search Domain is not specified in the search request, MSAS SHALL assign an appropriate Search Domain to the search request. The objective is to find the best available Search Domain for a particular request from a particular user. In order to find the appropriate Search Domain, all the available Search Domains are ranked as per their relevance. Following three relevance factors are considered. The sum all of the three factor forms the Search Domain's final relevance.
 - Similarity with search query: This considers how related the query (search keywords) is with a particular Search Domain. For example, the following steps can be performed
 - Define a query vector as Q(q₁, q₂, q₃, ...,q_n). Where, qi is the rank (importance) of a keyword k_i in the query.
 - Define a Search Domain vector as D(d₁, d₂, d₃, ... d_n). Where, d_i is the rank (relevance) of the Search Domain with the corresponding keyword k_i.
 - Compute the similarity between the two vector using cosine similarity algorithms.
 - Search Popularity: This considers the rate (number) of public search for this particular query, in a particular Search Domain, among the entire clientele. The rate of public search can be known by the total number of searches being performed with particular search keyword and Search Domain pair. Alternatively, it can be knows by the total number of user Interaction on the results produced by a particular search keyword and Search Domain pair. For example, the following steps can be performed
 - Computer the rate (number) of public search for each keyword in the query for a Search Domain.
 - Sum up the values of each keyword for a particular Search Domain.
 - Normalize the resultant value.
 - User's preference: This considers the user's preference in Search Domains. The Inter-Domain interest model is used for this purpose. The dimensions of user's Inter-Domain interest domain will provide user's preference in particular Search Domain.
- The MSAS SHALL remove the "Client-ID" parameter from the SearchRequest message.
- MSAS SHALL then forward the request to MSS on MSF-2.

6.2.3 Search Response Handling

After receiving search response, in SearchResponse message, from MSS on MSF-2, MSAS SHALL perform the following actions

- Apply the recommendation algorithm(s), mentioned in the SearchRequest message, to the results provided in the SearchResponse message as per the Search History & Recommendation function.
- If the response is for a search request made against a subscription from MSF-Client, MSAS SHALL forward the search response to the intended receiver (indicated by the Receiver-ID parameter in the subscription request) in NotifyRequest message on MSF-5. The response will be asynchronous.
- If the response is for a search request made against a search request from MSF-Client MSAS SHALL forward the search response to MSF-Client in SearchResponse message on MSF-1 if the Receiver-ID parameter was missing. In case the Receiver-ID parameter was present in the corresponding search request, the MSAS SHALL forward the search response to the MSF-Client on MSF-5 (being referred to by Receiver-ID parameter) instead of MSF-1.

6.2.4 Question Request Handling

After receiving QARequest message from MSF-Client on MSF-1, MSAS SHALL perform the following steps.

- Provide the acknowledgment for the QARequest message using out-of-scope mechanism.
- In case a QA Field is not specified by the user, MSAS SHALL assign a QA Field to the question request. It is RECOMMENDED that QA Field be similar with Search Domain. As such the mechanism for Search Domain mapping applies here as well.
- Select one or more Experts to answer the question posted. The selection is performed based on Expert Rank. Expert Rank is calculated/maintained based on the following factors but not limited to.
 - Number of times user providing positive feedback (best answer) for the answers provided by the particular Expert.
 - o Number of times particular Experts answering question from the user.
 - Number of times user clicks on the answers provided by the particular Expert.

Note: In the above three bullets "user" is referring to the "question submitter" (user who is actually submitting the question) as well as all the other MSrchFramework users.

- The MSAS SHALL remove the "Client-ID" parameter from the QARequest message.
- Forwards the request to MSS using QARequest message with additional parameters on MSF-2.

6.2.5 Question Response Handling

After receiving QAResponse message from MSS, MSAS SHALL perform the following steps.

- MSAS sort the answers. The sorting is performed based on Expert Rank as specified in section 6.2.4.
- MSAS SHALL return the response back to MSF-Client in QAResponse message.

6.2.6 Subscribe Request Handling

After receiving Subscribe request from MSF-Client, MSAS SHALL perform the following steps.

- MSAS SHALL initiate generation of search request according to the triggering conditions specified in Trigger-Criteria structure present in subscribes request from MSF-Client.
- MSAS SHALL generate search request according to the procedures specified in section 6.2.2.
- MSAS SHALL then forward search request to MSS using SearchRequest message.

Note: For MSS, this will be a mere search request.

6.2.7 Feedback Handling

When receiving a Feedback request message on MSF-1 interface, the MSAS SHALL perform the following actions:

- Store the feedback received and associate it to user and related result;
- If there is the agreement between service provider and MSF-Source to propagate Feedback received, then the MSAS

SHALL remove the "Client-ID" parameter from the FeedbackRequest message and propagate the FeedbackRequest message over MSF-2.

If the feedback received pertains to an advertisement, the MSAS SHALL NOT propagate the Feedback to MSS. However the MSAS MAY send to the Ad Server on MobAd-2 the SPAppMetricsReport message as defined in [OMA-MobAd-TS].

6.2.8 Targeted Advertising Handling

After receiving the SearchRequest, SubscribeRequest and QARequest from MSF-Client, the MSAS MAY act as SP App (Service Provider Application) and request for targeted advertisements from Ad Server (Advertising Server), via MobAd-2 interface, using the SPAppAdRequest message as defined in [OMA-MobAd-TS] with the following clarifications:

- The searchTerms or Tags in the SearchRequest, SubscribeRequest MAY be included in the SPAppAdRequest as ContextKeyword.
- The Question in the QARequest MAY be included in the SPAppAdRequest as ContextKeyword.
- The Client-ID in the SearchRequest, SubscribeRequest and QARequest MAY be used to generate the PrincipalID in the SPAppAdRequest. The MSAS-ID MAY be used as SPAppID in the SPAppAdRequest.

After receiving advertisement(s) in the SPAppAdResponse message from Ad Server, the MSAS MAY insert advertisement(s) into the search results and deliver them to the MSF-Client in the SearchResponse, QAResponse and NotifyRequest. The format of the advertisement SHALL be an Atom "entry" according to [RFC4287].

After delivering the advertisement(s) to MSF-Client, the MSAS SHALL send to the Ad Server on MobAd-2 the SPAppMetricsReport message as defined in [OMA-MobAD].

6.3 MSS Functionalities

6.3.1 Search Request Handling

6.3.1.1 From MSAS

When receiving a search request on MSF-2 interface, MSS perform the following actions:

- It SHALL check whether at least a SE is available for the requested Search-Domain. If no SE is available the MSS SHALL send an error message describing un-availability of the appropriate SE.
- In case one or more appropriate SE is available, the MSS SHALL select the appropriate SE(s). Several kind of SE selection are enabled such as:
 - o SE selection based on search query and Meta-Index
 - o SE selection based on search query, Meta-Index, User Interest Model

In case the selected SE belongs to a different MSS, the search request SHALL be forwarded to the related MSS on MSF-4 using SearchDispatchRequest message as defined in section 5.5.1.1 and SHALL NOT perform the following steps.

• For each SE, MSS SHALL convert the received search request into the request format supported by SE. The conversion is performed based on the mapping information, between search request format supported by MSS and the format supported by SE provided in the registration request. The detail Query Building function is defined in section 6.3.1.1.1. Note: If a parameter in search request doesn't map with a particular parameter supported by SE, the implementation may choose any other appropriate parameter, supported by SE, for that particular parameter. An appropriate parameter may be the general search (searchTerms) parameter.

- MSS SHALL collect the entire user related information if requested by the selected SE(s).
- MSS SHALL forward the request to all selected SE(s). MSS SHALL send user related information with the search request as/if requested by SE during registration. MSS SHALL not reveal user identification or point-of-contact in the information being sent.

Some guidelines for SE selection are provided in Appendix C.

6.3.1.1.1 Query Building function

As a part of Query building function, MSS SHALL form a HTTP request according to the specifics provided by SE at the time of registration. MSS:

- SHALL form a HTTP URL using the URL template provided by SE at the time of registration as a part OpenSearch description document.
 - SHALL carefully replace search parameters (coming on MSF-2) with corresponding URL parameters defined by SE in URL template at the time of registration.
- SHALL embed all the parameters provided as a part of OpenSearch parameter extension [PARA-EXT] in the request.
- SHALL embed other required information (e.g. domain specific information).

6.3.1.2 From MSS

When receiving a search request on MSF-4 interface from another MSS, MSS SHALL perform the following actions:

- MSS SHALL collect the entire user related information if requested by the selected SE(s).
- For each SE, MSS SHALL convert the received search request into the request format supported by SE. The conversion is performed based on the mapping information, between search request format supported by MSS and the format supported by SE provided in the registration request. The detail Query Building function is defined in section 6.3.1.1.1

Note: If a parameter in search request doesn't map with a particular parameter supported by SE, the implementation may choose any other appropriate parameter, supported by SE, for that particular parameter. One of the appropriate parameter may be the general search (searchTerms) parameter.

• MSS SHALL forward the request to all the SE provided in Selected-SE-List parameter in the request. MSS SHALL send user related information with the search request as/if requested by SE during registration. MSS SHALL NOT reveal user private information in the information being sent. The private information refers to any kind of information which may enable SEs to get acquainted with the user

6.3.2 Search Response Handling

On receiving a search response from SE/other MSS on MSF-4, MSS SHALL perform the following steps.

- For each SE, MSS SHALL review/understand the response as atom feeds.
- Depending on the domain mapping information, if provided in the registration request, MSS SHALL convert result format into the format used by this enabler.
- MSS SHALL aggregate the results from all the SE/other MSS.
- MSS SHALL check whether SE/other MSS has returned Personalization Score (calculated rank considering UIM, provided by MSS) with the search result.
 - In case the Personalization Score is not provided by the SE/other MSS, MSS generates Personalization Score (calculated rank considering UIM, provided by MSAS), for the entire result list, by itself.
 - MSS re-rank and sort the aggregated results list according to the Personalization Score, Local Rank and the Importance Level.
- It SHALL forward consolidated list of results to MSAS in SearchResponse message on MSF-2.

6.3.3 Question Request Handling

After receiving QARequest message from MSAS, MSS SHALL perform the following steps.

• Provide the acknowledgment for the QAR equest message using out-of-scope mechanism.

- Check the value of Ans-History parameter
 - If the value is TRUE, MSS SHALL get answer from Answer History and return the answer instantly using QAResponse. If no answer is found, MSS SHALL NOT forward the request to Experts, and return an error.
 - If the value is FALSE, MSS SHALL forward the request to selected experts indicated by MSAS in QARequest message.

6.3.4 Question Response Handling

After receiving an answer response in QAResponse message from Experts, MSS SHALL perform the following steps.

- MSS SHALL aggregate answers provided by all the experts.
- MSS SHALL send the consolidated list of answers to MSAS using QAResponse message.

6.3.5 Registration Request Handling

On receiving the registration request on MSF-3 interface, MSS SHALL perform following actions:

- MSS SHALL check/validate the description document as a valid [OpenSearch] descriptor document
- If the registration request is from a SE, MSS SHALL generate a unique Provider-ID and send that to the SE in RegistrationResponse message. MSS SHALL NOT include ConfirmedList parameter.
- If the registration request is form another MSS, MSS SHALL generates a unique Provider-ID and sends that to the registering MSS in RegistrationResponse message. MSS SHALL include the list of SEs (Source-ID, as provided in SE structure) for which the Meta-Index is required, in ConfirmedList parameter.

6.3.6 Meta-Index Update request handling

On receiving a Meta-Index update request from other MSS, MSS SHALL response back with the required SE(s) list in the RegistrationResponse message.

On receiving an Meta-Index update request from a SE, MSS SHALL duly update the SE's information (including Meta-Index) as specified in the request.

6.3.7 Meta-Index Update

To update a previously submitted Meta-Index, anytime after registration, with MSS, an other MSS SHALL perform following actions:

- It SHALL create a RegistrationRequest message as follows
 - It SHALL include the list of new (newly registered SE) and updated (SE those have updated their Meta-Index) SEs in SE structure.
 - o It SHALL NOT include General-reg-info parameter.
- Receive, as a response, the required SE(s) list in RegistrationResponse message.
- Submit Meta-Index only for those SE specified in the ConfirmedList message.

6.3.8 MSS Registration

To register with the MSS, other MSS SHALL perform the following actions:

- Other MSS SHALL send the required registration information using RegistrationRequest message.
 - The RegistrationRequest message is an OpenSearch description document. In addition to the URL Parameters defined by OpenSearch, other MSS may also use the extended URL parameters and other extensions like SE structure defined in this specification.
- Other MSS SHALL submit its Meta-Index, only for those SE mentioned in ConfirmedList parameter of RegistrationResponse message, using SubmitMeta-Index message.

6.3.9 Feedback Handling

When receiving a FeedbackRequest message on MSF-2 interface, the MSS SHALL perform the following actions:

- associate the feedback received to the right result and SE;
- send the FeedbackDispatchRequest message to the SE on MSF-4.

6.3.10 Questions Retrieve Response Handling

After receiving a QRetrieveRequest from Expert, MSS SHALL perform the following steps:

- MSS SHALL check the request parameters against the unanswered questions;
- MSS SHALL send the retrieved list of questions to Expert using QRetrieveResponse message on MSF-3.

6.4 SE Functionalities

6.4.1 Registration

To register with the MSS, SE SHALL perform the following actions

- SE SHALL send the required registration information using RegistrationRequest message
 - The RegistrationRequest message is an OpenSearch description document.
 - In addition to the URL Parameters defined by OpenSearch, a SE MAY also use the URL parameters defined in section 8.3 to require user-related information.
 - The description document MAY also include other information like the SE structure defined in section 8.2.18.
- After receiving RegistrationResponse, SE SHALL submit its Meta-Index using SubmitMeta-Index message.

6.4.2 Search Request Handling

On receiving a search request from MSS on MSF-4 SE SHALL perform the following steps.

- SE SHALL check whether the request contains the User Interest Model (User-im)
 - o If UIM is provided then SE SHALL use it for ranking and sorting the result list produced.
 - o SE SHALL calculate Personalization Score for each result.
- SE SHALL return result list to MSS. SE SHALL include Personalization Score with each result in case it has performed ranking and sorting based on UIM. SE may also include Local Rank calculated as per its own policies.

6.4.3 Meta-Index Update

To update previously submitted Meta-Index, at any time after registration, SE SHALL send a SubmitMeta-Index message to MSS.

6.5 Expert Functionalities

6.5.1 Questions Retrieve Request

To retrieve unanswered questions, Expert SHALL send a request using QRetrieveRequest message on MSF-3 to MSS

7. Protocol Bindings

7.1 HTTP Bindings

7.1.1 General

MSF-Client SHALL support Hypertext Transfer Protocol version 1.1 (HTTP1.1 [RFC2616]) for MSF-1 and MSF-5 interfaces.

MSAS SHALL support Hypertext Transfer Protocol version 1.1 (HTTP1.1 [RFC2616]) for MSF-1 and MSF-2 interfaces.

MSS SHALL support Hypertext Transfer Protocol version 1.1 (HTTP1.1 [RFC2616]) for MSF-2, MSF-3, and MSF-4 interfaces.

SE SHALL support Hypertext Transfer Protocol version 1.1 (HTTP1.1 [RFC2616]) for MSF-3 and MSF-4 interfaces.

7.1.1.1 Media Type

MSF-Client SHALL support messages formatted as entity-bodies with the following media types:

- multipart/form-data media type. The multipart/form-data media type is used on MSF-1 interface when sending the HTTP request.
- application/xml media type. The application/xml media type is used on MSF-1 interface when receiving the HTTP response.

MSAS SHALL support messages formatted as entity-bodies with the following media types:

- multipart/form-data media type. The multipart/form-data media type is used
 - o on MSF-1 interface when receiving the HTTP request;
 - o on MSF-2 interface when sending the HTTP request.
- application/xml media type. The application/xml media type is used
 - o on MSF-1 interface when sending the HTTP response;
 - o on MSF-2 interface when receiving the HTTP response.
- multipart/mixed media type. The multipart/mixed media type is used when multiple MSrchFramework interface messages are concatenated in a single HTTP request/response on MSF-2.

MSS SHALL support messages formatted as entity-bodies with the following media types:

- multipart/form-data media type. The multipart/form-data media type is used
 - o on MSF-2 interface when receiving the HTTP request;
 - o on MSF-4 interface when sending the HTTP request depending on SE registration
- application/x-www-form-urlencoded media type. The application/x-www-form-urlencoded media type is used on MSF-4 interface when sending the HTTP request depending on SE registration
- application/xml media type. The application/xml media type is used when a single MSrchFramework interface message is included in the HTTP request/response
 - o on MSF-2 interface when sending the HTTP response.
 - o on MSF-3 when sending/receiving HTTP request/response.
- multipart/mixed media type. The multipart/mixed media type is used when multiple MSrchFramework interface messages are concatenated in a single HTTP request/response on MSF-2 and MSF-3.

SE SHALL support messages formatted as entity-bodies with the following media types:

- application/x-www-form-urlencoded media type. The application/x-www-form-urlencoded media type is used on MSF-4 interface when receiving the HTTP request depending on SE registration
- application/xml media type. The application/xml media type is used in the HTTP request/response.

7.1.1.2 HTTP Method

All the request messages SHALL be sending as HTTP POST method requests.

The following optional Headers may be included in the request messages.

- the receiver's address in the request line
- the Host request-header set to the hostname or IP address of the receiver.
- the User-Agent request-header set to identify the host device (e.g. "vendor-model/version"), and the name and version of the sender as user agent initiating the request.
- the Accept request-header with value "application/xml, multipart/mixed"
- the Accept-Encoding request-header with value per the supported HTTP compression encodings, i.e. deflate and / or gzip
- the Accept-Language request-header with value per the supported HTTP supported languages(e.g. en, *)
- the Accept-MsgSize is the maximum message size that terminal can handle.
- the Content-Length entity-header set to the length of the entity-body
- the Content-Type entity-header with value "application/xml", "multipart/mixed" or "multipart/form-data" as applicable
- the Interface message(s) as message-body

If any of these headers are not present in the response to the request, the receiver SHALL assume their *default* values.

All the response messages SHALL be sending as response to the corresponding receiver's request as specified by the HTTP 1.1 including:

- Status-Line header reflects the outcome of the HTTP POST request
- the ETag entity-header set to a unique value within the scope of the receiver.
- the Content-Encoding entity-header set to the type of HTTP compression applied, if any
- the Content-Length entity-header set to the length of the entity-body
- the Content-Type entity-header with value "application/xml or "multipart/mixed", as applicable

the Interface message(s) as message-body, if the transaction is successful

7.1.1.3 HTTP Authentication

The MSF-Client and MSAS SHALL support HTTP Digest Authentication mechanisms (HTTP1.1 [RFC2617]) on MSF-1 interface.

7.1.2 MSF-1 Interface Message Bindings

7.2 OMA Push Bindings

The MSAS SHALL support either the Push Access Protocol (PAP) [PUSH-PAP] or the Push-OTA protocol [PUSH-OTA] for point-to-point delivery of the following messages over the MSF-5 interface:

- MSF-5 SearchResponse
- MSF-5 NotifyRequest
- MSF-5 QAResponse

Whether to use PAP or Push-OTA is a deployment choice. Among other advantages, use of PAP prevents the MSAS from needing to implement most of the basic functions of OMA Push Proxy Gateway (PPG), e.g. the various Push-OTA protocols and target client context/capabilities awareness (as needed to select the appropriate transport bearer and protocol). Conversely, for high-volume search services limited to Push delivery over a single specific bearer (e.g. WAP1 Push over SMS), use of Push-OTA is fairly simple and avoids dependency upon a Push Proxy Gateway (PPG).

MSrch messages may not be directly deliverable over connectionless bearers such as WAP Push over SMS (limited to about 512 bytes) or SIP Push via the SIP MESSAGE method (limited to about 1300 bytes), as compared to WAP Push over HTTP or SIP Push via the INVITE/MSRP method (both of which support essentially unlimited content size). The alternative to direct delivery is "indirect delivery", which involves the delivery of a Push notification message carrying a content location URL, from which the client retrieves the response.

When using PAP for direct MSrch message delivery, the MSAS SHALL submit the MSrch messages using the MIME content type "application/xml" or "multipart/mixed", as applicable, and MAY support various target client address schemes, e.g. PLMN, USER, SIP URI, IP address, etc.

When directly delivering MSrch messages via Push-OTA, the MSAS SHALL send the MSrch message (headers and message body) encapsulated into a message/vnd.oma.push media type as described in [PUSH-MSG].

To deliver MSF-5 messages indirectly, the MSAS SHALL use the ServiceLoading [PUSH-SL] content type, via either PAP or Push-OTA as applicable, and include a URL from which the MSF-Client can retrieve the actual MSF-5 message. MSF-Clients SHALL support indirect delivery of MSrch messages, triggered by reception of ServiceLoading notifications.

For MSrch Push messages, the MSAS SHALL include the Push Application ID header "X-Wap-Application-Id: x-omaapplication:msrch.ua". Push Clients in MSrch supporting terminals SHALL support routing of Push messages with the Push Application ID header "X-Wap-Application-Id: x-oma-application:msrch.ua" to the MSF-Client. If there is no Push Client in the device, the MSF-Client SHALL implement the necessary Push Client functions for the supported Push-OTA protocol variants per [PUSH-OTA].

MSF-Clients SHALL support direct and indirect Push delivery of the MSrch messages:

- MSF-5 SearchResponse
- MSF-5 NotifyRequest
- MSF-5 QAResponse

8. Data Model

8.1 Data Types

The datatypes of the MSrchFramework parameters used in this specification are defined in the section "Built-in datatypes" of [XML Schema Part 2: Datatypes] specification by the W3C.

8.2 Common parameters and structures

8.2.1 Result Structure

The format of a Result SHALL be an Atom "entry" according to [RFC4287].

The following table shows the Atom representation of the elements of a Result. In addition, this specification uses some of the GeoRSS elements and further defines new elements in Result entries.

Unless indicated otherwise, the XML elements in the "Atom Representation" column are in the Atom namespace and defined in [RFC4287]. In particular, items containing the "geo:" prefix are defined in [GEORSS] specification and items containing the "oma:" prefix are defined in this specification.

Domain-specific parameters or additional general result parameters, e.g. URL, actual content parameters related to multimedia content MAY be added to the Result using other Atom elements as defined in [RFC4287] or any other extension.

Appendix C. SE Selection Guidelines (Informative)

This section provides guidelines for SE selection based on different criteria.

C.1 SE Selection based on similarity between query and Meta-Index

The main idea behind SE selection based on query and Meta-Index is to find the SE having the most similar document/record with the query itself. More precisely, a SE having the maximum normalized occurrences of query terms across its documents. The SE's individual Meta-Index should serve as a source for term-document statistics (e.g. what term is appearing how many times in the SE's documents).

To achieve appropriate SE selection, all SE's can be ranked according to their important. The SE with the highest rank will them be selected. The following formula can be used to rank a particular SE based on the similarity between query and Meta-Index.

$Msim1=Max1 <= i <= n\{qi*gidfi*t-mnwi\}$

Where,

qi is the importance of the ith term (of the query) with in the query itself.

t-mnwi is the maximum normalized Term Frequency of ith term (of the query) across all the SE's document. This value is expected to be provided by SE in their respective Meta-Index while registration.

gidfi is inverse of the number of documents actually containing the ith term in the SE database. The inverse is considered to avoid incorrectly emphasizing long documents which happen to use the word like "the" more, without giving enough weight to the more meaningful terms "president" and "india".

The SE's ranked highest (maximum Msim1) will be selected.

C.2 SE Selection based on similarity between query, Meta-Index and User Interest Model.

In addition to the similarity between query and Meta-Index, user preference in Search Domain/Search Sub-Domain (which can be known by Inter-Domain and Intra-Domain interest model) may also be considered while SE selection. This selection method will screen SE based on which SE has the most relevant document pertaining to the Search Sub-Domain preferred by user. The SE's individual Meta-Index should serve as a source for document and Search Sub-Domain statistics (e.g. how well the documents are relevant to a particular Search Sub-Domain preferred by user, in SE's database).

The following formula can be used to rank SE based on the relevance between query, Meta-Index and User Interest Model.

$Msim2=Max_{1 <=i <=n} \{r_i*Di-mnw_i\} + Msim1$

Where,

- r_i is the importance of a particular Search Sub-domain in the Intra-Domain Interest Model. This UIM can be long-term (GENERAL) or instant (SESSION-BASED) or a weighted sum of both.
- Di-mnw is the Search Sub-Domain's maximum normalized Domain Relevance across all the documents. This value
 is expected to be provided by SE in their respective Meta-Index while registration.
- Msim1 is the SE rank based on query and Meta-Index.

The SE's ranked highest (maximum Msim2) will be selected.
