1. Scope

The present document provides the PoC Service Interworking specification by means of endorsement of the OMA-TS-POC-ControlPlane-V2 "OMA PoC Control Plane", OMA-TS-POC-UserPlane-V2 "OMA PoC User Plane" and OMA-TS-XDM_Core-V2 "XML Document Management (XDM) Specification" and documentation of applicability and exception thereof in line with the requirements for PoC Interworking Service [OMA-POC-RD].

The present document is applicable to the PoC Interworking Function and PoC Interworking Agent providing PoC Interworking Service functionality.

3. Terminology and Conventions

3.1 Conventions

The key words "MUST", "MUST NOT", "REQUIRED", "SHALL", "SHALL NOT", "SHOULD", "SHOULD NOT", "RECOMMENDED", "MAY", and "OPTIONAL" in this document are to be interpreted as described in [RFC2119].

All sections and appendixes, except "Scope" and "Introduction", are normative, unless they are explicitly indicated to be informative.

3.2 Definitions

For the purposes of the present document, beyond the terms and definitions in the endorsed specifications [OMA-POC-CP], [OMA-POC-UP], [XDMSPEC] the following terms and definitions from [OMA-POC-AD] and [OMA-POC-SD] apply:

| External P2T Networks | Private or public circuit switched or packet switched network that provide push to talk services similar to PoC services. |

| P2T Address | A P2T Address identifying a P2T User. The P2T Address can be used by PoC Users to communicate with P2T Users. The P2T Address used in a PoC Network points to the PoC Interworking Agent of the P2T User in the PoC Interworking service. |
| P2T User | A P2T User is a user of the P2T service provided by an External P2T Network. |
| PoC Interworking Agent | Abstract entity implemented in the PoC Interworking Function, acting as a PoC Client on behalf of a PoC Remote Access User or a P2T User. |
| PoC Interworking Function | Part of the PoC Interworking Service, it provides conversion between PoC Network based SIP signalling, Talk Burst Control and Media Burst Control Protocol, and Media packet transport, and External P2T Network based session signaling, floor control, and Media transport protocol. |
| PoC Interworking Service | A means to extend the PoC User experience beyond the OMA defined PoC service and PoC Network boundaries, accomplished by interworking with other networks and systems, while not PoC compliant, being able to provide a reasonably comparable capability, involving simplex Media based conferencing. |
| PoC Remote Access | A method of providing a compliant PoC User access to a SIP/IP Core and PoC Network via an potentially non-SIP/IP based network. |
| PoC Remote Access User | A user of the PoC service accessing the service potentially via a non IMS enabled SIP/IP based network, not necessarily using a PoC Client (e.g. a PoC User, with a valid subscription, accessing PoC services via a PSTN terminal). |
| Push To Talk Service (P2T) | Non OMA PoC "walkie-talkie" service. |

4. Introduction

PoC Interworking Service supports three different topologies based on the following basic usage scenarios:

- 1. P2T Users participate in the PoC Session and PoC Session control is in the PoC Network;
- 2. PoC Users participate in the PoC Session and PoC Session control is in the P2T Network; and
- 3. PoC Remote Access User(s) participates in the PoC Session.




Figure 1: Usage scenario 1 with PoC Interworking Function performing the Participating PoC Function.

In support of usage scenario 1 the PoC Interworking Function performs the Participating PoC Function as shown in Figure 1

The rule to be applied to the endorsed specifications in support usage scenario 1 is a general replacement of the "PoC Server performing the Participating PoC Function" with the "PoC Interworking Function performing the Participating PoC Function".




Figure 2: Usage scenario 2 with PoC Interworking Function performing the Controlling PoC Function.

In support of usage scenario 2 the PoC Interworking Function performs the Controlling PoC Function as shown in Figure 2.

The rule to be applied to the endorsed specifications in support usage scenario 2 is a general replacement of the "PoC Server performing the Controlling PoC Function" with the "PoC Interworking Function performing the Controlling PoC Function".




Figure 3: Usage scenario 3 with PoC Interworking Agent supporting PoC Remote Access.

In support of usage scenario 3 the PoC Interworking Agent is used to connect to the PoC Server performing the Participating PoC Function as shown in Figure 3

The PoC Interworking Agent behaves towards the PoC Network A like a PoC Client and XDM Client. The rule to be applied to the endorsed specifications in support usage scenario 3 is a general replacement of the "PoC Client" and "XDM Client" with the "PoC Interworking Agent".

The document is structured in the following way:

Clause 5: "Endorsement of OMA PoC Control Plane" contains the endorsement of [OMA-POC-CP] document.

Apply the general statements referring to the PoC Server also for the PoC Interworking Function.

In order to support usage scenario 1 as described in clause 4 "*Introduction*" in the present document replace "PoC Server performing the Participating PoC Function" with "PoC Interworking Function performing the Participating PoC Function" in all requirements.

In order to support usage scenario 2 as described in clause 4 "*Introduction*" in the present document replace "PoC Server performing the Controlling PoC Function" with "PoC Interworking Function performing the Controlling PoC Function" in all requirements.

In order to support usage scenario 3 as described in clause 4 "*Introduction*" in the present document replace "PoC Client" with PoC Interworking Agent"

Apply the the statements referring to PoC Users also for P2T Users and PoC Remote Access Users.

Clause 1 "Scope" in [OMA-POC-CP] does not apply and is replaced by the clause 1 "Scope" in the present document.

Clause 2 "References" in [OMA-POC-CP] apply with modifications.

The references listed below are replaced by references applicable to PoC Interworking Service.

• Subclauses related to Signalling Compression: 5.3 do not apply, and the text in each subclause is replaced with the following note:

NOTE: The use of Signalling Compression is not a requirement for the PoC Interworking Service. The use of the Signalling Compression within the PoC Network is not visible at the open interface to the PoC Interworking Service.

- Subclause 5.6. applies with following exceptions:
- Warning Header Codes related to Pre-established sessions, Simultaneous PoC Sessions and PoC Box features are not supported.

Clause 6 "Procedures at the PoC Client" in [OMA-POC-CP] applies with modifications and following exceptions:

• For usage scenario 3 sub-clause 6.1.3.1, 6.1.8, 6.1.9, 6.1.10, 6.2.11 apply with following addition:

The PoC Interworking Agent SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header of all initial SIP requests;

• Subclauses related to Pre-established Session: 6.1.3.2, 6.1.5.2, 6.1.6.2, 6.2.3.2 do not apply and the text in each subclause is replaced with the following note:

- NOTE: The use of the Pre-established Session feature is not a requirement for the PoC Interworking Service. The use of the Pre-established Session within the PoC Network is not visible at the open interface to the PoC Interworking Service.
- Subclauses related to Simultaneous PoC Sessions: 6.1.12, 6.2.7 do not apply and the text in each subclause is replaced with the following note:
- NOTE: The use of the Simultaneous PoC Sessions feature is not a requirement for the PoC Interworking Service. The use of the Simultaneous PoC Sessions feature within the PoC Network is not visible at the open interface to the PoC Interworking Service. The Simultaneous PoC Sessions feature can be used on behalf of a PoC Remote Access User if supported by the corresponding PoC Client.

Clause 7 "Procedures at the PoC Server" in [OMA-POC-CP] applies with following exceptions and modifications:

• For usage scenario 2 sub-clauses 7.2.1.1, 7.2.1.2, apply with following addition:

When generating a SIP response the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 2 sub-clauses 7.2.1.11.2 apply with following addition:

When generating a SIP NOTIFY request the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 2 sub-clauses 7.2.1.12, 7.2.2.6, 7.2.2.7 apply with following addition:

When generating a SIP reponse or a SIP MESSAGE the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 1 sub-clauses 7.3.1.1, 7.2.1.2, apply with following addition:

When generating/forwarding a SIP request/response the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header

• For usage scenario 1 sub-clauses 7.3.1.7 apply with following addition:

When forwarding a SIP SUBSCRIBE request the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 1 sub-clauses 7.3.1.11 apply with following addition:

When generating/forwarding a SIP MESSAGE the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 1 sub-clauses 7.3.2.4 apply with following addition:

When forwarding a SIP NOTIFY request the PoC Interworking Function SHALL add PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 1 sub-clauses 7.3.2.7, 7.3.2.8, 7.4.1.1 apply with following addition:

When forwarding a SIP MESSAGE the PoC Interworking Function SHALL add the PoC feature tag '+g.poc.interworking' to the Contact header.

• For usage scenario 1 sub-clause 7.3.3.1 applies with following addition:

When generating a SIP SUBSCRIBE the PoC Interworking Function SHALL add PoC feature tag '+g.poc.interworking' to the Contact header.

- Subclauses related to Pre-established Session: 7.3.1.2, 7.3.1.3, 7.3.1.5, 7.3.1.10.2, 7.3.2.2.2, 7.3.2.6.2, 7.3.2.6.3 do not apply and the text in each subclause is replaced with the following notes:
- NOTE: The use of the Pre-established Session feature is not a requirement for the PoC Interworking Service. The use of the Pre-established Session within the PoC Network is not visible at the open interface to the PoC Interworking Service.

- Subclauses related to Simultaneous PoC Sessions: 7.3.1.12 does not apply and the text in each subclause is replaced with the following note:
- NOTE: The use of the Simultaneous PoC Sessions feature is not a requirement for the PoC Interworking Service. The use of the Simultaneous PoC Sessions feature within the PoC Network is not visible at the open interface to the PoC Interworking Service. The Simultaneous PoC Sessions feature can be used on behalf of a PoC Remote Access User if supported by the corresponding PoC Client.

Subclause 8 "*PoC Box*" in [OMA-POC-CP] does not apply and the text in each subclause is replaced with the following note:

NOTE: The use of the PoC Box feature is not a requirement for the PoC Interworking Service. The use of the PoC Box feature within the PoC Network is not visible at the open interface to the PoC Interworking Service.

- Subclauses related to Pre-established Session: F.2 and F.3 do not apply and the text in each subclause is replaced with the following notes:
- NOTE: The use of the Pre-established Session feature is not a requirement for the PoC Interworking Service. The use of the Pre-established Session within the PoC Network is not visible at the open interface to the PoC Interworking Service.
- Subclauses related to Simultaneous PoC Sessions: F.10 does not apply and the text in each subclause is replaced with the following note:
- NOTE: The use of the Simultaneous PoC Sessions feature is not a requirement for the PoC Interworking Service. The use of the Simultaneous PoC Sessions feature within the PoC Network is not visible at the open interface to the PoC Interworking Service. The Simultaneous PoC Sessions feature can be used on behalf of a PoC Remote Access User if supported by the corresponding PoC Client.
- In support of usage scenario 1 replace the "PoC Server performing the Participating PoC Function" with the "PoC Interworking Function performing the Participating PoC Function" and the respective "PoC Client" with "P2T Client" in the signalling flows.
- In support of usage scenario 2 replace the "PoC Server performing the Controlling PoC Function" with the "PoC Interworking Function performing the Controlling PoC Function" and of the "PoC Client" in the controlling network with "P2T Client" in the signalling flows.
- In support of usage scenario 3 replace the "PoC Client" with the "PoC Interworking Agent" for the PoC Remote Access User in the signalling flows.

Apply the general statements referring to the PoC Client also for the PoC Interworking Agent.

Apply the general statements referring to the PoC Server also for the PoC Interworking Function.

In order to support usage scenario 1 as described in clause 4 "*Introduction*" in the present document replace "PoC Server performing the Participating PoC Function" with "PoC Interworking Function performing the Participating PoC Function" in all requirements.

In order to support usage scenario 2 as described in clause 4 "*Introduction*" in the present document replace "PoC Server performing the Controlling PoC Function" with "PoC Interworking Function performing the Controlling PoC Function" in all requirements.

In order to support usage scenario 3 as described in clause 4 "*Introduction*" in the present document replace "PoC Client" with "PoC Interworking Agent"

Apply the the statements referring to PoC Users also for P2T Users and PoC Remote Access Users.

Clause 1 "Scope" in [OMA-POC-UP] does not apply and is replaced by the clause 1 "Scope" in the present document.

Clause 2 "References" in [OMA-POC-UP] apply with modifications.

The references listed below are replaced by references applicable to PoC Interworking Service.

Reference no.OMA-TS-POC-UserPlane-V2 [OMA-POC-UP]Applicable reference is this document[OMA-PoC-CP]OMA Push to talk over Cellular (PoC) – Control PlaneThis document.[XDMSPEC]XML Document Management (XDM) Specification.This document.

Clause 3 "Terminology and Conventions" in [OMA-POC-UP] applies with the additions in the clause 3 "Terminology and Conventions" in this document.

Clause 4 "Introduction" in [OMA-POC-UP] applies.

Clause 5 "Transport" in [OMA-POC-UP] applies with the following additions:

• Add at the end of the subclause 5.3 "*RTP*":

The Interworking Agent SHALL remove RTP Media packets received from the PoC Client when only the following fields are included:

• Add at the end of the subclause 5.4 "*RTCP*":

NOTE: The Interworking Agent discards any RTP Media packets received from the PoC Client for keeping the RTCP session binding through NATs on the RTCP port open.

• Add at the end of the subclause 5.5 "*MSRP*" the following:

The Interworking Agent needs to support a method for NAT traversal (e.g. [RFC 4145], [RFC 3489bis], etc) if connecting PoC Clients on an IP Network behind a NAT.

Clause 6 "Media Burst Control" in [OMA-POC-UP] applies with following exceptions:

- Subclauses related to Pre-established Session: 6.2.2, 6.2.4, 6.2.6, 6.3.4, 6.3.6 do not apply and the text in each subclause is replaced with the following notes:
- NOTE: The use of the Pre-established Session feature is not a requirement for the PoC Interworking Service. The use of the Pre-established Session within the PoC Network is not visible at the open interface to the PoC Interworking Service.
- Subclauses related to Simultaneous PoC Sessions: 6.2.7, 6.2.8, 6.3.7, 6.3.8 do not apply and the text in each subclause is replaced with the following notes:
- NOTE: The use of the Simultaneous PoC Sessions feature is not a requirement for the PoC Interworking Service. The use of the Simultaneous PoC Sessions feature within the PoC Network is not visible at the open interface to the PoC Interworking Service. The Simultaneous PoC Sessions feature can be used on behalf of a PoC Remote Access User if supported by the corresponding PoC Client.
- Subclauses related to queuing of Media Burst requests: 6.2.9, 6.5.10, 6.5.11 do not apply and the text in each subclause is replaced with the following notes:
- NOTE: The use of the queuing of Media Burst requests is not a requirement for the PoC Interworking Service. The use of queuing of Media Burst requests within the PoC Network is transparent for the PoC Interworking Service. Queuing of Media Burst requests can be used on behalf of a PoC Remote Access User if supported by the corresponding PoC Client.
