# 1. Scope

The scope of this document is given by the Enabler Release Definition of Immersive Social Centre (ISC) enabler according to OMA Release process and the Enabler Release specification baseline listed in section 5.

The ISC Enabler defines a service-level framework providing a standardized integration of content viewing and communication experience. This includes the use of multiple devices (e.g. smartphones, TV, tablets, PC) in order to enable an immersive (“being there” and “being with”) experience.

The scope of the enabler covers the specification of a common interface between clients and servers and between servers to ensure interoperability. This includes a description of an architecture in order to support all defined requirements and to support all necessary entities to ensure enriched communication between them and external applications.

## 3. Terminology and Conventions

### 3.1 Conventions

The key words “MUST”, “MUST NOT”, “REQUIRED”, “SHALL”, “SHALL NOT”, “SHOULD”, “SHOULD NOT”, “RECOMMENDED”, “MAY”, and “OPTIONAL” in this document are to be interpreted as described in [RFC2119].

All sections and appendixes, except “Scope”, “Release Version Overview” and “Conformance Requirements Notation Details”, are normative, unless they are explicitly indicated to be informative.

The formal notation convention used in sections 8 and 9 to formally express the structure and internal dependencies between specifications in the Enabler Release specification baseline is detailed in [SCRRULES].

### 3.2 Definitions

<b>Enabler Release</b>	Collection of specifications that combined together form an enabler for a service area, e.g. a download enabler, a browsing enabler, a messaging enabler, a location enabler, etc. The specifications that are forming an enabler should combined fulfil a number of related market requirements.
<b>Minimum Functionality Description</b>	Description of the guaranteed features and functionality that will be enabled by implementing the minimum mandatory part of the Enabler Release.

## 4. Release Version Overview

The Immersive Social Centre (ISC) Enabler defines an overall framework that enables a standardized integration of content viewing and communication experience.

The core functionalities exposed by the ISC Enabler include: immersive content viewing environment, multi-device support, synchronization, user interaction and management, social communication capabilities, security and privacy aspects.

### 4.1 Version 1.0 Functionality

The version 1.0 of the ISC Enabler supports the following functionalities (not exhaustive):

- do content viewing and communication (e.g., send invitation, post comments) with other users in parallel;
- synchronize their content view with other user(s) ;
- share information of their content viewings (e.g., content name, same view or not) and presence information (e.g. available/not available for content viewing) ;
- get list of contents (personalized) available for viewing along with metadata and preview of the content;
- receive content views according to published device capability and spatial configuration;
- concurrently associate several devices with themselves;
- interact with the content (e.g., voting, delegate content viewing rights) ;
- personalise their services by setting preferences;
- store content viewed and associated communication in the network;
- support security and privacy aspects.
