3. Terminology and Conventions

3.1 Conventions

The key words “MUST”, “MUST NOT”, “REQUIRED”, “SHALL”, “SHALL NOT”, “SHOULD”, “SHOULD NOT”, “RECOMMENDED”, “MAY”, and “OPTIONAL” in this document are to be interpreted as described in [RFC2119].

All sections and appendixes, except “Scope”, "Release Version Overview" and “Conformance Requirements Notation Details”, are normative, unless they are explicitly indicated to be informative.

The formal notation convention used in sections 8 and 9 to formally express the structure and internal dependencies between specifications in the Enabler Release specification baseline is detailed in [SCRRULES].

3.2 Definitions

Enabler Release	Collection of specifications that combined together form an enabler for a service area, e.g. a download enabler, a browsing enabler, a messaging enabler, a location enabler, etc. The specifications that are forming an enabler should combined fulfil a number of related market requirements.
Minimum Functionality Description	Description of the guaranteed features and functionality that will be enabled by implementing the minimum mandatory part of the Enabler Release.
Software Component	A software component is a resource utilized by the mobile Device software platform

4. Release Version Overview

The Software Component Management Object enables remote Software Component management within Device. This can be used for example to update antivirus software or browser plug-in etc.

Management operations defined for the purpose of Software Component management on the Device support delivery, download, installation, update, removal, activation & de-activation. In addition, retrieval of inventory of Software Components on the Device is also supported.

4.1 Version 1.0 Functionality

The Software Component Management Object (SCOMO) V1.0 Enabler [SCOMO-TS] supports the following functionality.

- Support for delivery of Software Components to a device
- Support for installation of Software Components on a device
- Support for update of Software Components on a device
- Support for removal of Software Components from a device
- Support for activation of Software Components on a device
- Support for deactivation of Software Components on a device
- Support for inventory query of Software Components on the device
