# 1. Scope

This document describes the Internal Location Protocol (ILP) for SUPL 3.0. ILP is a protocol-level instantiation of the Llp reference point defined in [SUPL 3.0 AD]. ILP is used between a SLC (SUPL Location Center) and a SPC (SUPL Positioning Center). For more details about SUPL 3.0 Requirements refer to [SUPL 3.0 RD]. For more details about SUPL 3.0 architecture and message flows, refer to [SUPL 3.0 AD] and [SUPL 3.0 TS ULP].

Of all the service scenarios and message flows supported in SUPL 3.0, only those which involve ILP are discussed in this document. All other service scenarios and message flows are omitted i.e., are not repeated in this document. Please refer to [SUPL 3.0 TS ULP] for a complete description of all supported service scenarios and message flows.

The target audience for this specification is developers, systems or network engineers developing or deploying SUPL.

## 3. Terminology and Conventions

### 3.1 Conventions

The key words “MUST”, “MUST NOT”, “REQUIRED”, “SHALL”, “SHALL NOT”, “SHOULD”, “SHOULD NOT”, “RECOMMENDED”, “MAY”, and “OPTIONAL” in this document are to be interpreted as described in [RFC 2119].

All sections and appendixes, except “Scope” and “Introduction”, are normative, unless they are explicitly indicated to be informative.

### 3.2 Definitions

Area ID	Area ID is the identity of an area in a wireless network.
I-WLAN	The interworking WLAN refers to the system for interworking between 3GPP/3GPP2 systems and WLAN. The intent of 3GPP/3GPP2–WLAN Interworking is to extend 3GPP/3GPP2 services and functionality to the WLAN access environment. The 3GPP/3GPP2–WLAN Interworking System provides bearer services allowing a 3GPP/3GPP2 subscriber to use a WLAN to access 3GPP/3GPP2 PS based services.
Location ID	The Location ID defines the current serving cell, current serving WLAN AP or current serving WiMAX BS information of the SET.
LPP	LPP implies use of LPP only
LPPe	LPPe implies use of LPP and LPPe
Major Version	Major versions are likely to contain major feature additions; MAY contain incompatibilities with previous specification revisions; and though unlikely, could change, drop, or replace standard or existing interfaces. Initial releases are “1_0”. [OMAOPS]
Minor Version	Minor versions are likely to contain minor feature additions, be compatible with the preceding Major version. Minor specification revision include existing interfaces, although it MAY provide evolving interfaces. The initial minor release for any major release is “0”, i.e. 1_0 [OMAOPS]
Multiple Location IDs	The Multiple Location IDs parameter may contain current non-serving cell, current non-serving WLAN AP or current non-serving WiMAX BS information for the SET and/or historic serving or non-serving cell, WLAN AP or WiMAX BS information for the SET.
Quality of Position	A set of attributes associated with a request for the geographic position of SET. The attributes include the required horizontal accuracy, vertical accuracy, max location age, and response time of the SET position.
Service Indicator	Service indicators are intended to be compatible with the Major_ Minor release they relate to but add bug fixes. No new functions will be added through the release of Service Indicators. [OMAOPS]
SUPL Roaming	For positioning not associated with an emergency services call, SUPL roaming occurs when a SET leaves the service area of its H-SLP. For positioning associated with an emergency services call, SUPL roaming occurs when the SET is not within the service area of the E-SLP. The service area of an H-SLP or E-SLP includes the area within which the H-SLP or E-SLP can provide a position estimate for a SET or relevant assistance data to a SET without contacting other SLPs. It should be noted that an H-SLP or E-SLP service area is not necessarily associated with the service area(s) of the underlying wireless network(s). In the case of service from a D-SLP, the H-SLP will normally assign a geographic service area within which the SET may access the D-SLP. Service from a D-SLP where the SET is roaming outside the assigned service area of the D-SLP is not supported.

This specification describes the ILP protocol release 3.0, a protocol-level instantiation of the Llp reference point. The Llp reference point was introduced in SUPL in release 2.0. Use of ILP allows SUPL operators to use an open interface (Llp) between the SLC and the SPC. Whether or not Llp is present in a particular implementation is optional. The presence (or absence) of Llp in a particular implementation is transparent to SUPL. The presence of Llp in an implementation does not in itself imply that SLC and SPC are deployed as physically separate network elements.

NOTE: Some parameters and messages from SUPL 2.0 TS ILP are no longer applicable in SUPL 3.0. However, due to code backwards compatibility, these parameters and messages are still listed in this document and are present in the ILP ASN.1 encoding. Parameters and messages no longer applicable in SUPL 3.0 are marked as such.

## 5. Message Flows

Of all the message flows supported in SUPL 3.0, only those which involve ILP are shown in this section. All other message flows are omitted. Please refer to [SUPL 3.0 TS ULP] for a complete description of all SUPL 3.0 message flows. Please also note that message flows shown in this section are limited to non roaming scenarios since roaming has no impact on ILP (and ULP) message flows<sup>1</sup>. Please refer to [SUPL 3.0 TS ULP] for a detailed description of roaming scenarios.

The message flow descriptions presented in this section are focused on ILP. A more general description of the message flows and services involved (immediate service, deferred service, etc.) can be found in [SUPL 3.0 TS ULP] and is not repeated here.

**NOTE:** In SUPL 3.0 it is possible to use LPP (by itself), LPP+LPPe or TIA-801 as positioning protocol. Therefore the following convention applies: *LPP* implies use of *LPP only* (i.e. without LPPe), *LPPe* implies use of *LPP and LPPe* and *TIA-801* implies use of *TIA-801 only*. A SUPL POS (LPP/LPPe/TIA-801) message means a SUPL POS message carrying either LPP, LPP+LPPe or TIA-801 positioning payload.

**NOTE:** To simplify the message flows, the mandatory ILP header parameter sessionID2 and the mandatory ULP header parameter sessionID are not shown in the message flow diagrams.

**NOTE:** ILP message flows described in this section are limited to the H-SLP and E-SLP, respectively. D-SLP ILP message flow scenarios (i.e., message flows between the D-SLC and the D-SPC) are not shown since they are identical to H-SLP ILP message flows.

**NOTE:** Optional parameters in the call flow diagrams of this chapter are shown in gray.

## 5.1 Immediate Service

### 5.1.1 Network Initiated Single Fix

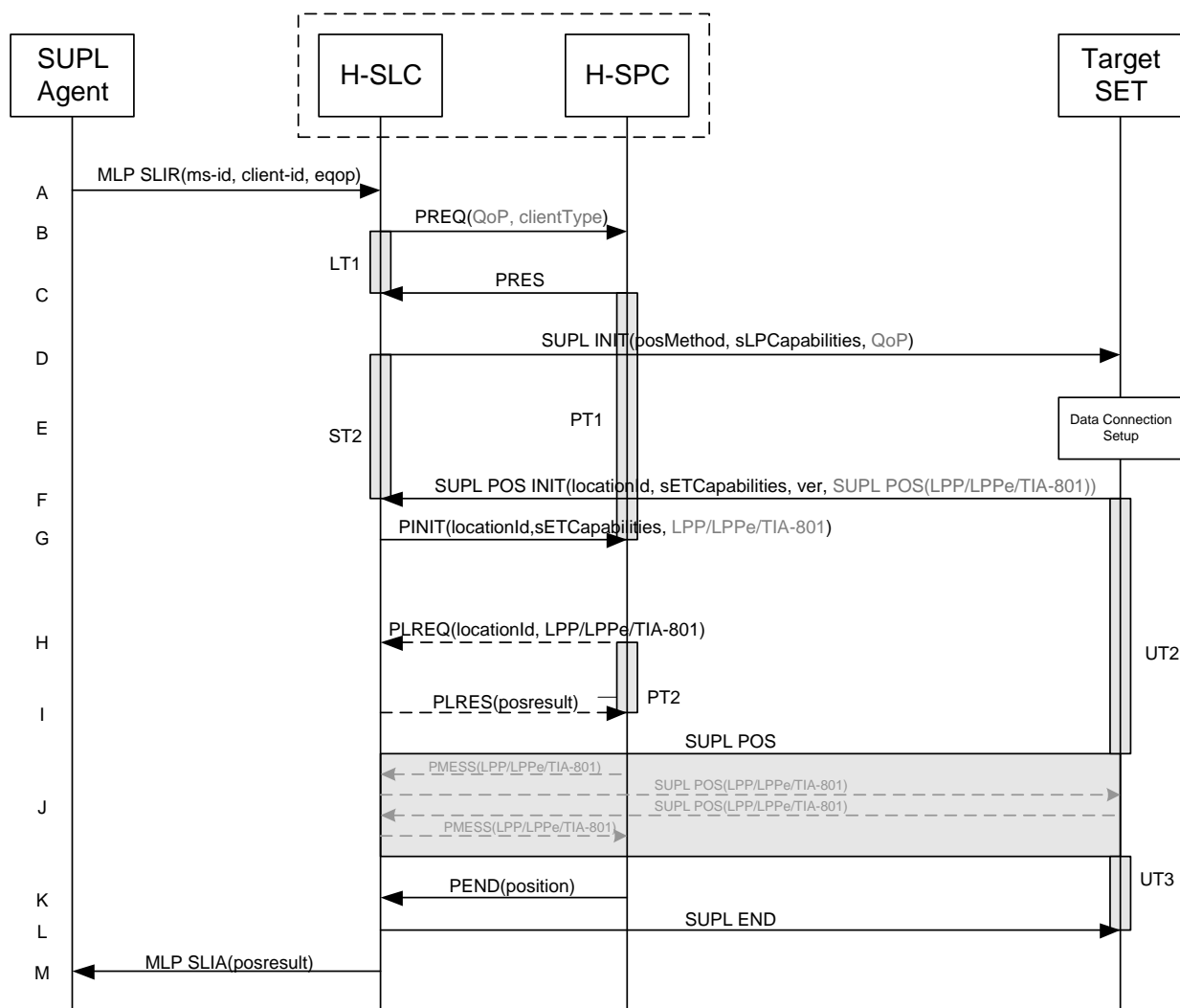


Figure 1: Network Initiated Single Fix

NOTE: See Appendix C for timer descriptions.

- A. The SUPL Agent issues an MLP SLIR message to the H-SLC, with which the SUPL Agent is associated. If a previously computed position which meets the requested QoP is available at the H-SLC and no notification or verification is required, the H-SLC SHALL directly proceed to step M. If notification and verification or notification only is required, the H-SLC SHALL proceed to step D.
- B. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message optionally containing the QoP and/or the client Type. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods are approved.
- C. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.

- D. The H-SLC initiates the location session with the SET by sending a SUPL INIT message to the SET. The SUPL INIT message contains the intended positioning method (*posMethod*), the SLP Capabilities (*sLPCapabilities*) and optionally the *QoP*. If the result of the privacy check in step A indicates that notification and/or verification of the target subscriber is needed, the H-SLC SHALL also include the Notification parameter in the SUPL INIT message. Before the SUPL INIT message is sent, the H-SLC also computes and stores the hash of the SUPL INIT message. If in step A the H-SLC decided to use a previously computed position, the SUPL INIT message SHALL indicate this in a 'no position' *posMethod* parameter value and the SET SHALL respond with a SUPL END message carrying the results of the verification process (access granted, or access denied). If no explicit verification is required (notification only) the SET SHALL respond with a SUPL END message. The H-SLC SHALL then directly proceed to step M.
- E. The SET analyses the received SUPL INIT message. If found not to be authentic, the SET takes no further action. Otherwise, the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC. The SET also calculates the hash of the received SUPL INIT message.
- F. The SET evaluates the Notification rules and takes the appropriate action. The SET SHALL establish a TLS connection to the H-SLC using the H-SLP address provisioned by the Home Network. The SET then sends a SUPL POS INIT message to start a positioning session with the H-SLP. The SET SHALL send the SUPL POS INIT message even if the SET does not support the intended positioning method indicated in SUPL INIT. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and the hash (*ver*) of the received SUPL INIT message calculated in step E. The SUPL POS INIT message MAY also include a SUPL POS message carrying LPP/LPPE and/or TIA-801 positioning protocol messages in line with the H-SLP's positioning protocol capabilities (indicated in step B in *sLPCapabilities*). The SET MAY also provide its position, if this is supported. If the SUPL POS INIT message contains a position which meets the requested QoP, the H-SLC MAY directly proceed to step L and not engage in a SUPL POS session. The H-SLC then also sends a PEND message to the SPC to end the session.
- G. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step F. The H-SLC MAY include a posmethod in the PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step C, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC. If a posmethod was included in the PINIT message, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in PINIT, the H-SPC shall choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step B. If required for the posmethod the H-SPC SHALL use the appropriate positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- H. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step G into a position estimate. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.
- I. This step is conditional and only occurs if step H was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- J. The H-SLC SHALL verify that the value of the *ver* parameter received in SUPL POS INIT in step F matches the one calculated and stored by the H-SLC in step D. If the values do not match, the H-SLC SHALL directly move to step L and send a SUPL END message with status code '*authSuplinitFailure*'. The H-SLC then also sends a PEND message to the SPC to end the session. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- K. Once the position calculation is complete the H-SPC sends a PEND message including the position result (*position*) to the H-SLC.

- L. The H-SLC sends a SUPL END message to the SET to end the session. The SET SHALL release the TLS connection to the H-SLC and release all resources related to this session.
- M. The H-SLC sends the position estimate back to the SUPL Agent in an MLP SLIA message and SHALL release all resources related to this session.

### 5.1.2 SET Initiated Single Fix

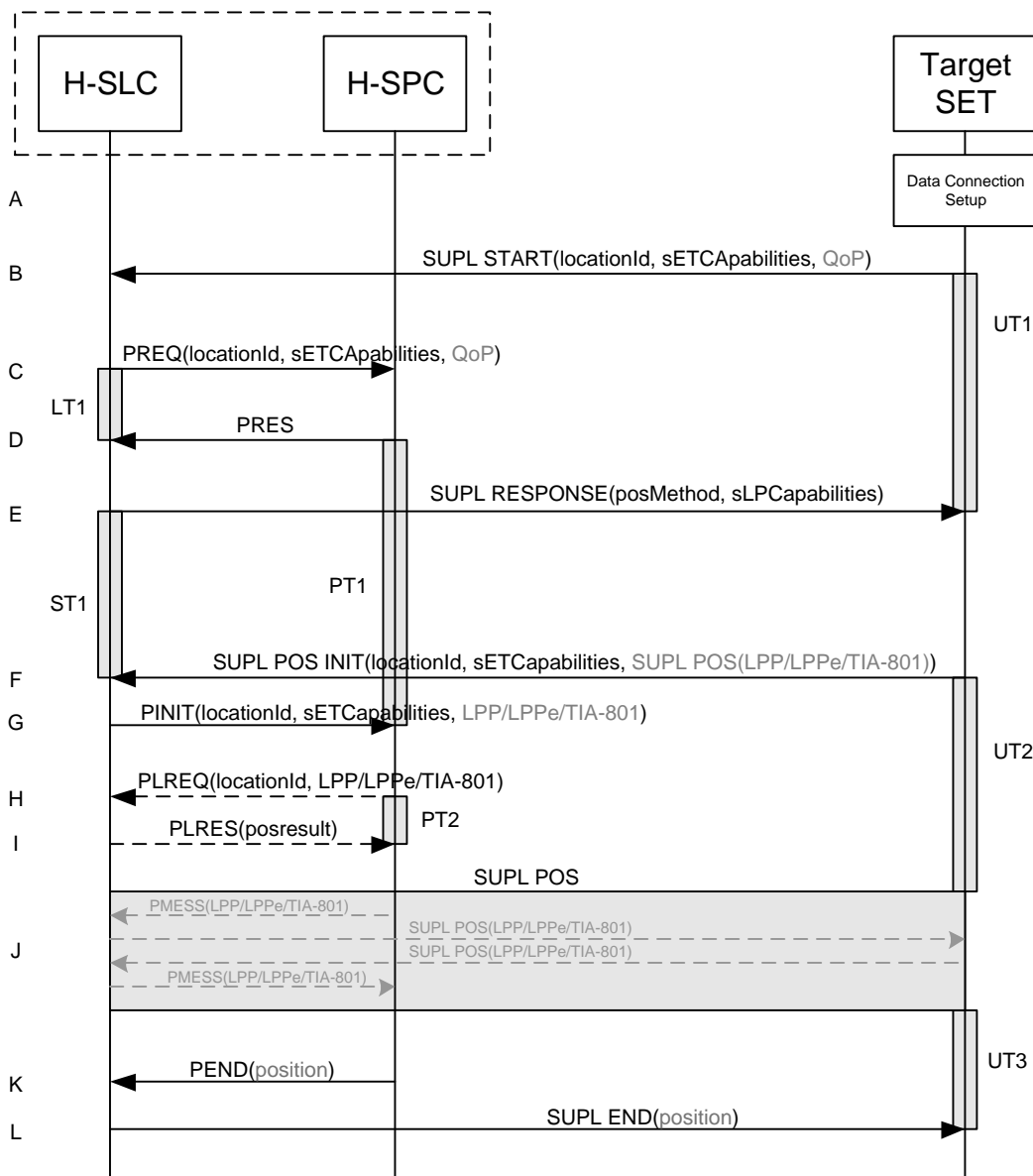


Figure 2: SET-Initiated Single Fix

NOTE: See Appendix C for timer descriptions.

- A. The SUPL Agent on the SET receives a request for position from an application running on the SET. The SET takes appropriate action to establish or resume a TLS connection to the H-SLC.
- B. The SET uses the default address provisioned by the Home Network to establish a TLS connection to the H-SLC and sends a SUPL START message to start a positioning session with the H-SLP. The SUPL START message contains the Location ID (*locationId*), SET capabilities (*sETCApabilities*)



and optionally the desired QoP. If a previously computed position which meets the requested QoP is available at the H-SLC, the H-SLC SHALL directly proceed to step L i.e., send a SUPL END message to the SET including the position result (*position*).

- C. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message including the Location ID (*locationId*), SET Capabilities (*sETCapabilities*) and optionally the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods are approved.
- D. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- E. The H-SLC SHALL respond with a SUPL RESPONSE message containing the intended positioning method (*posMethod*) and the SLP Capabilities (*sLPCapabilities*). If the H-SPC included a list of supported posmethods in step D, the chosen intended positioning method SHALL be aligned with the list of supported posmethods.
- F. The SET SHALL send a SUPL POS INIT message to the H-SLC. The SET SHALL send the SUPL POS INIT message even if the SET does not support the intended positioning method indicated in SUPL RESPONSE in step E. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and optionally a SUPL POS message carrying LPP/LPPE/TIA-801 positioning protocol messages in line with the H-SLP's positioning protocol capabilities (indicated in step E in *sLPCapabilities*).
- G. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step F. The H-SLC MAY include a posmethod in PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step D, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC.  
If a posmethod was included in PINIT, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in the PINIT, the H-SPC shall choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step C. If required for the posmethod the H-SPC SHALL use the supported positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session
- H. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step G into a position. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.
- I. This step is conditional and only occurs if step H was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- J. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- K. Once the position calculation is complete the H-SPC sends a PEND message to the H-SLC including – if applicable – the position result.

- L. The H-SLC sends a SUPL END message to the SET including – if applicable – the position result and ends the session. The SET SHALL release the secure connection to the H-SLC and release all resources related to this session.

### 5.1.3 Exception Procedures

#### 5.1.3.1 SET Does Not Allow Positioning

After receiving a SUPL INIT message the SET executes the notification/verification procedure. In this scenario, the subscriber rejects the location request.

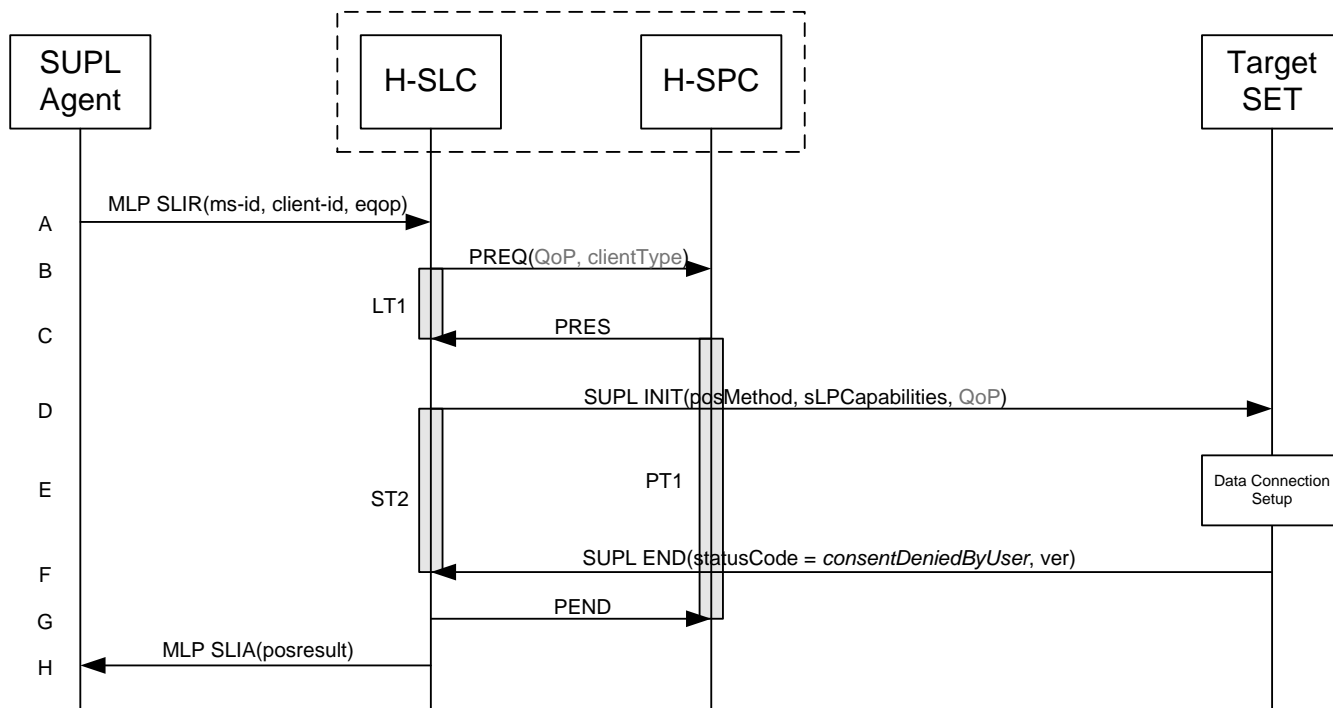


Figure 3: Network Initiated SET User Rejects Positioning

- A. The SUPL Agent sends an MLP SLIR message to the H-SLC, with which the SUPL Agent is associated.
- B. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message optionally containing the desired QoP and the client type (*clientType*). The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- C. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- D. The H-SLP initiates the location session with the SET using the SUPL INIT message. In this case the result of the privacy check in Step A indicated that notification or verification to the target subscriber is required, and the H-SLC therefore includes the Notification element in the SUPL INIT message
- E. The SET analyses the received SUPL INIT. If found to be non authentic, the SET takes no further action. Otherwise the SET takes needed action preparing for establishment or resumption of a TLS connection.
- F. The SET evaluates the notification rules and alerts the subscriber of the position request. In this case the user rejects the location request, either explicitly or implicitly by not responding to the notification. The SET returns a SUPL

END message to the H-SLC containing a hash of the received SUPL INIT message (ver) and the status code *consentDeniedByUser*.

G. The H-SLC sends a PEND message to the H-SPC to terminate the SUPL session.

H. The H-SLC sends qn MLP SLIA message including the appropriate error-code to the SUPL Agent.

### 5.1.3.2 SUPL Protocol Error

When a SUPL protocol error occurs and as a result the SUPL session is terminated, a PEND message is sent by the SLC or SPC to its counterpart (i.e. SPC or SLC) and the SUPL session is ended.

### 5.1.3.3 Timer expiration

Timer expirations are defined in Appendix C.

## 5.1.4 Network Initiated Single Fix, Notification/Verification based on current location

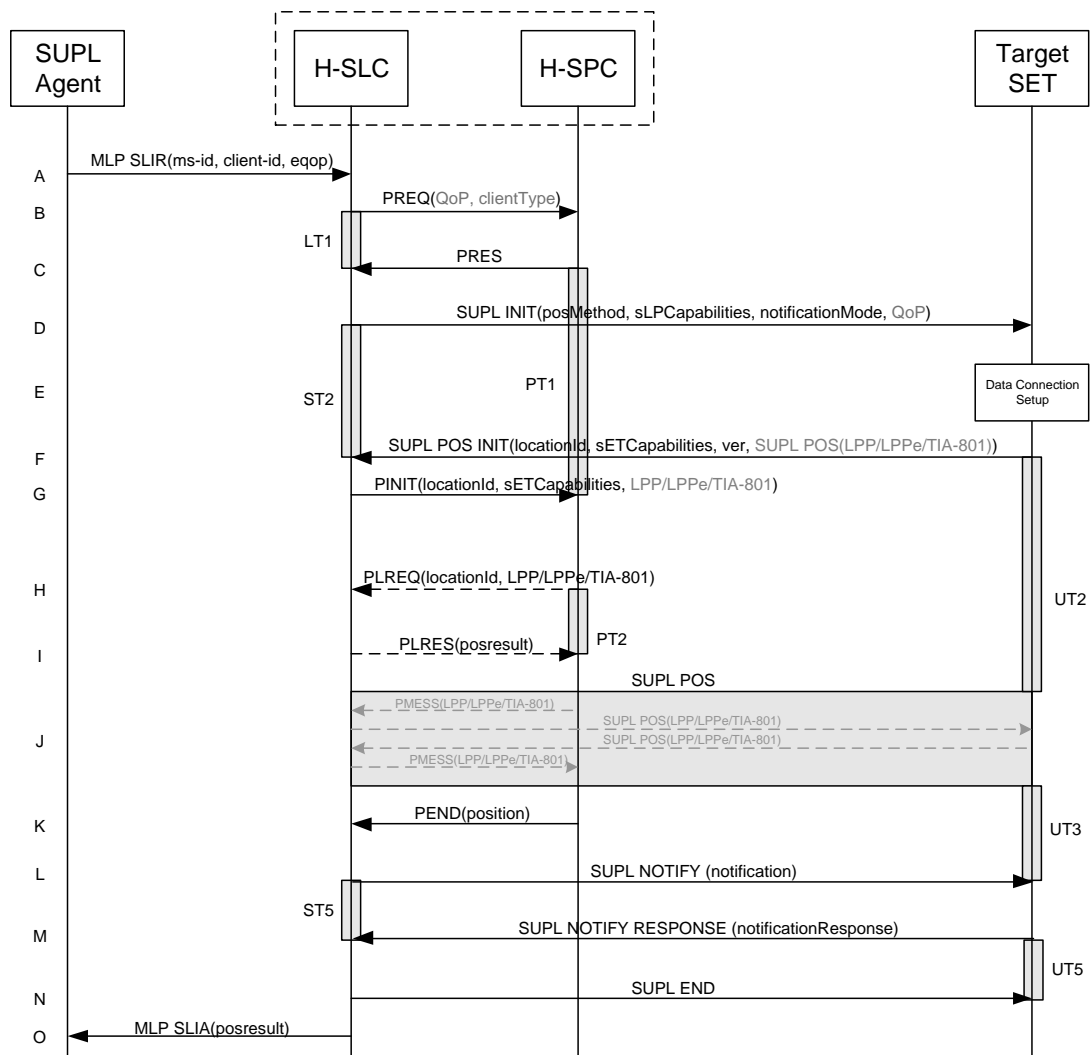


Figure 4: Network Initiated Single Fix, Notification/Verification based on current location

NOTE: See Appendix C for timer descriptions.

- A. The SUPL Agent issues an MLP SLIR message to the H-SLC, with which the SUPL Agent is associated. If a previously computed position which meets the requested QoP is available at the H-SLC and, based on that position, no notification or verification is required, the H-SLC SHALL directly proceed to step O. If, based on that position, notification and verification or notification only is required, the H-SLC SHALL proceed to step D.
- B. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message optionally containing the QoP and/or the client Type. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods are approved.
- C. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- D. The H-SLC initiates the location session with the SET by sending a SUPL INIT message to the SET. The SUPL INIT message contains the intended positioning method (*posMethod*), the SLP Capabilities (*sLPCapabilities*) and optionally the *QoP*. As in this case the result of the privacy check in Step A indicates that subscriber privacy check based on current location is required, the H-SLP SHALL include the Notification Mode element (*notificationMode*) in the SUPL INIT message to indicate notification based on current location and SHALL NOT include the notification element in the SUPL INIT message. Before the SUPL INIT message is sent, the H-SLC also computes and stores the hash of the SUPL INIT message.  
If in step A the H-SLC decided to use a previously computed position, the SUPL INIT message SHALL indicate this in a 'no position' *posMethod* parameter value and the SET SHALL respond with a SUPL END message carrying the results of the verification process (access granted, or access denied). If no explicit verification is required (notification only) the SET SHALL respond with a SUPL END message. The H-SLC SHALL then directly proceed to step O.
- E. The SET analyses the received SUPL INIT message. If found not to be authentic, the SET takes no further action. Otherwise, the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC. The SET also calculates the hash of the received SUPL INIT message.
- F. The SET evaluates the Notification rules and takes the appropriate action. The SET checks the notification mode indicator and determines that in this case the notification is performed based on the location of the SET. The SET SHALL establish a TLS connection to the H-SLC using the H-SLP address provisioned by the Home Network. The SET then sends a SUPL POS INIT message to start a positioning session with the H-SLP. The SET SHALL send the SUPL POS INIT message even if the SET does not support the intended positioning method indicated in SUPL INIT message. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and the hash (*ver*) of the received SUPL INIT message calculated in step E. The SUPL POS INIT message MAY also include a SUPL POS message carrying LPP/LPPe and/or TIA-801 positioning protocol messages in line with the H-SLP's positioning protocol capabilities (indicated in step D in *sLPCapabilities*). The SET MAY also provide its position, if this is supported. If the SUPL POS INIT message contains a position which meets the requested QoP, the H-SLC MAY directly proceed to step L and not engage in a SUPL POS session. The H-SLC then also sends a PEND message to the SPC to end the session.
- G. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPe/TIA-801 payload received in step F. The H-SLC MAY include a posmethod in the PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step C, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC.  
If a posmethod was included in the PINIT message, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in PINIT, the H-SPC shall choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step B. If required for the posmethod the H-SPC SHALL use the appropriate positioning protocol (e.g. LPP, LPPe or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- H. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPe/TIA-801 payload received in step G into a position estimate. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPe/TIA-801 payload to the H-SLC.

- I. This step is conditional and only occurs if step H was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- J. The H-SLC SHALL verify that the value of the *ver* parameter received in SUPL POS INIT in step F matches the one calculated and stored by the H-SLC in step D. If the values do not match, the H-SLC SHALL directly move to step N and send a SUPL END message with status code '*authSuplinitFailure*'. The H-SLC then also sends a PEND message to the SPC to end the session.  
SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- K. Once the position calculation is complete the H-SPC sends a PEND message including the position result (*position*) to the H-SLC.
- L. The H-SLC applies subscriber privacy against the SET position estimate determined in Step K. If, based on this position, notification and verification or notification only is required, the H-SLC SHALL send a SUPL NOTIFY message to the SET. The SUPL NOTIFY message contains the notification element (*notification*). If, based on this position, no notification or verification is required, the H-SLP SHALL directly proceed to Step N.
- M. The SET SHALL send a SUPL NOTIFY RESPONSE message to the H-SLC. If notification and verification was required in Step L then this will contain the containing the notification response from the user.
- N. The H-SLC sends a SUPL END message to the SET to end the session. The SET SHALL release the TLS connection to the H-SLC and release all resources related to this session.
- O. The H-SLC sends the position estimate back to the SUPL Agent in an MLP SLIA message and SHALL release all resources related to this session.

## 5.2 Emergency Services

This section describes the handling of Emergency Service Location Requests.

### 5.2.1 Network Initiated

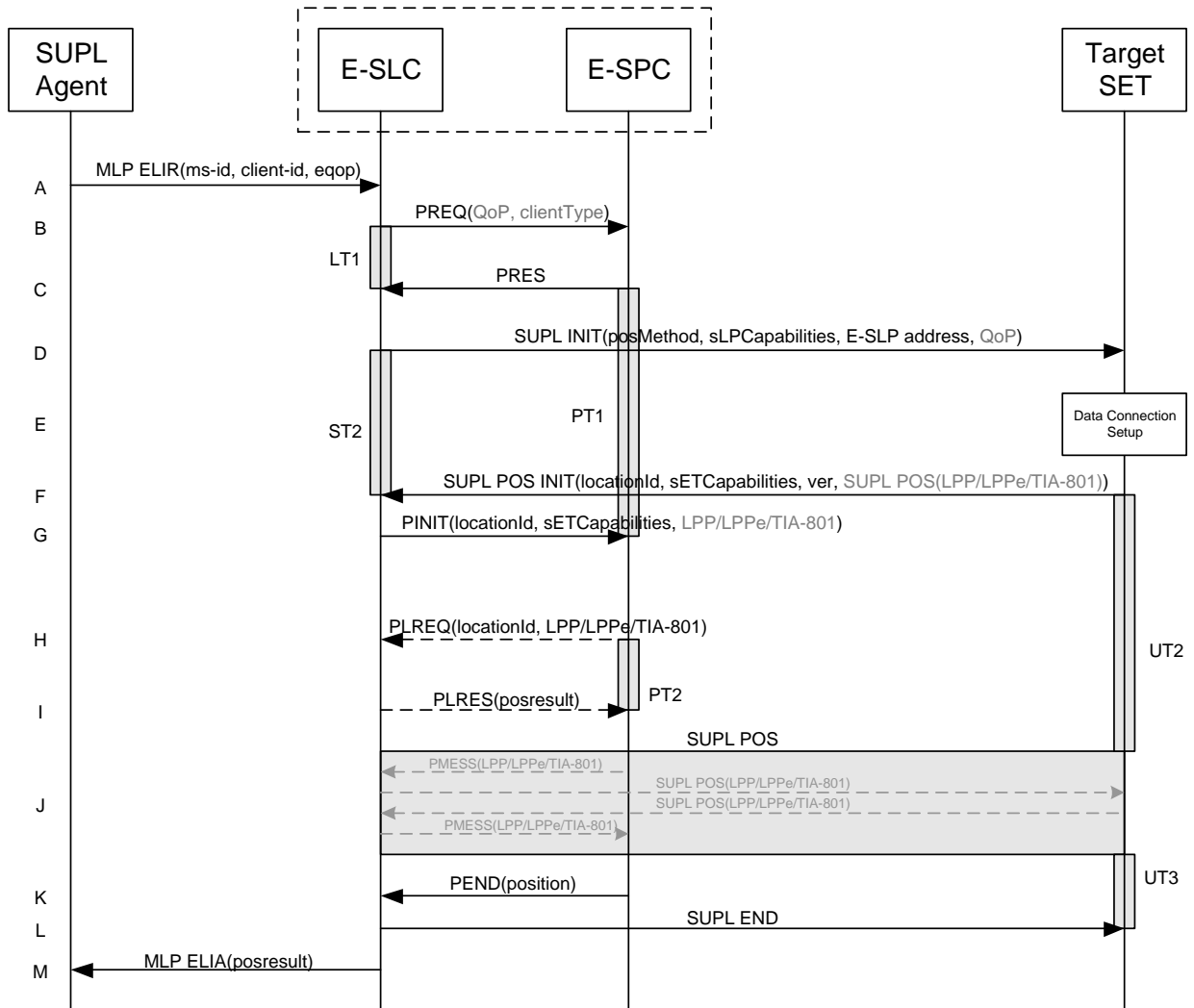


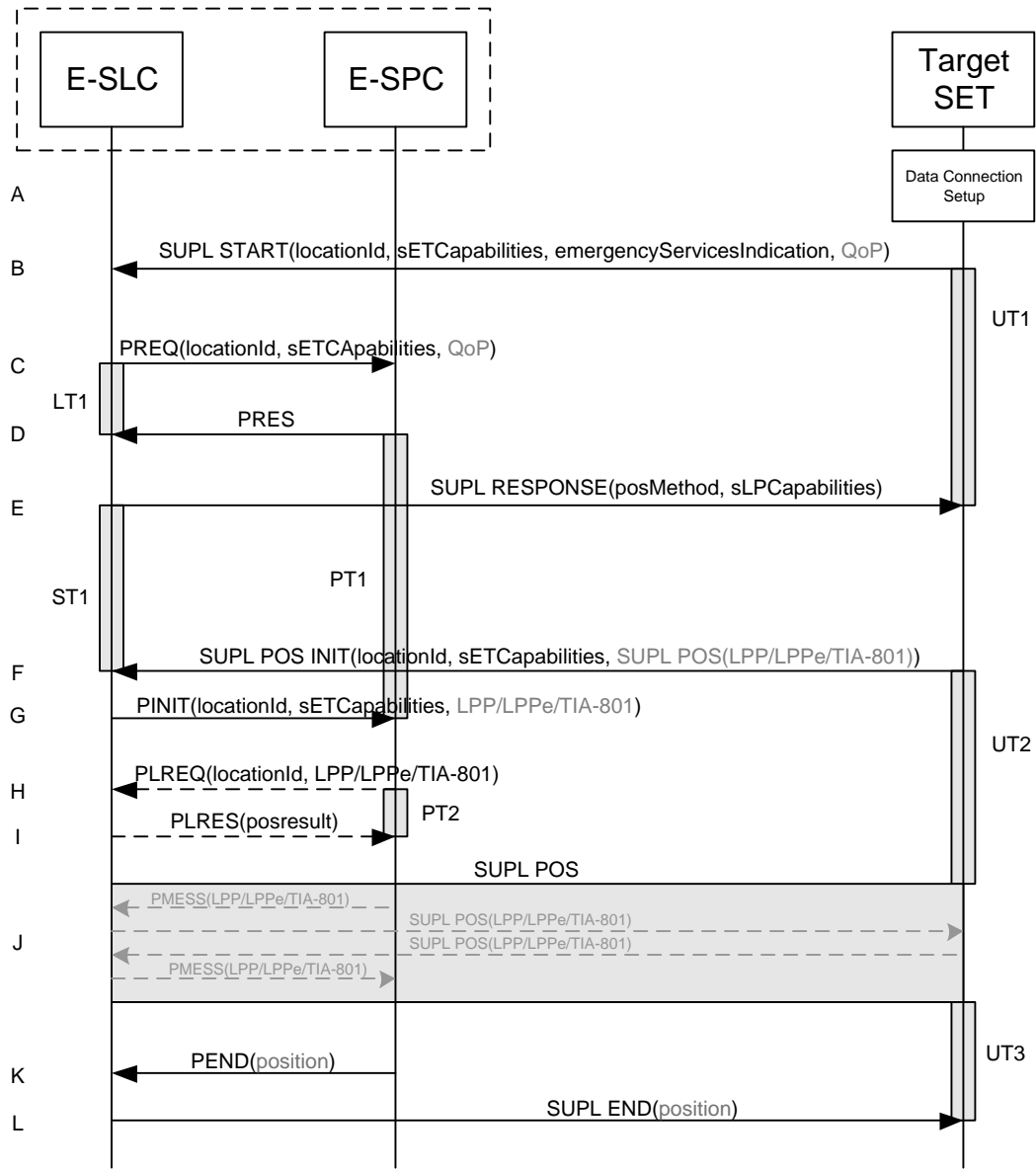
Figure 5: Network Initiated Emergency Service

The ILP/ULP message flow for Network Initiated Emergency Service is the same as for immediate single fix (see section 5.1.1). The only difference is that the H-SLP is replaced by an E-SLP<sup>2</sup> and in step B the PREQ message from the E-SLC to the E-SPC indicates the SUPL session request is for an emergency call in the appropriate client type (clientType=Emergency). The fact that the SUPL INIT message carries the address of the E-SLP has no impact on overall message flow.

<sup>2</sup> In certain scenarios the H-SLP may also serve as the E-SLP.

### 5.2.2 SET Initiated

The ILP/ULP message flow for SET Initiated Emergency Service is the same as for immediate single fix (see section 5.1.2). The only difference is that the H-SLP is replaced by an E-SLP and in step C the PREQ message from the E-SLC to the E-SPC indicates the SUPL session request is for emergency services in the appropriate client type (clientType=Emergency). The fact that the SUPL START message carries the Emergency Services Indication parameter (*emergencyServicesIndication*) has no impact on overall message flow.

### 5.3 Deferred Services

#### 5.3.1 Network Initiated Triggered Periodic

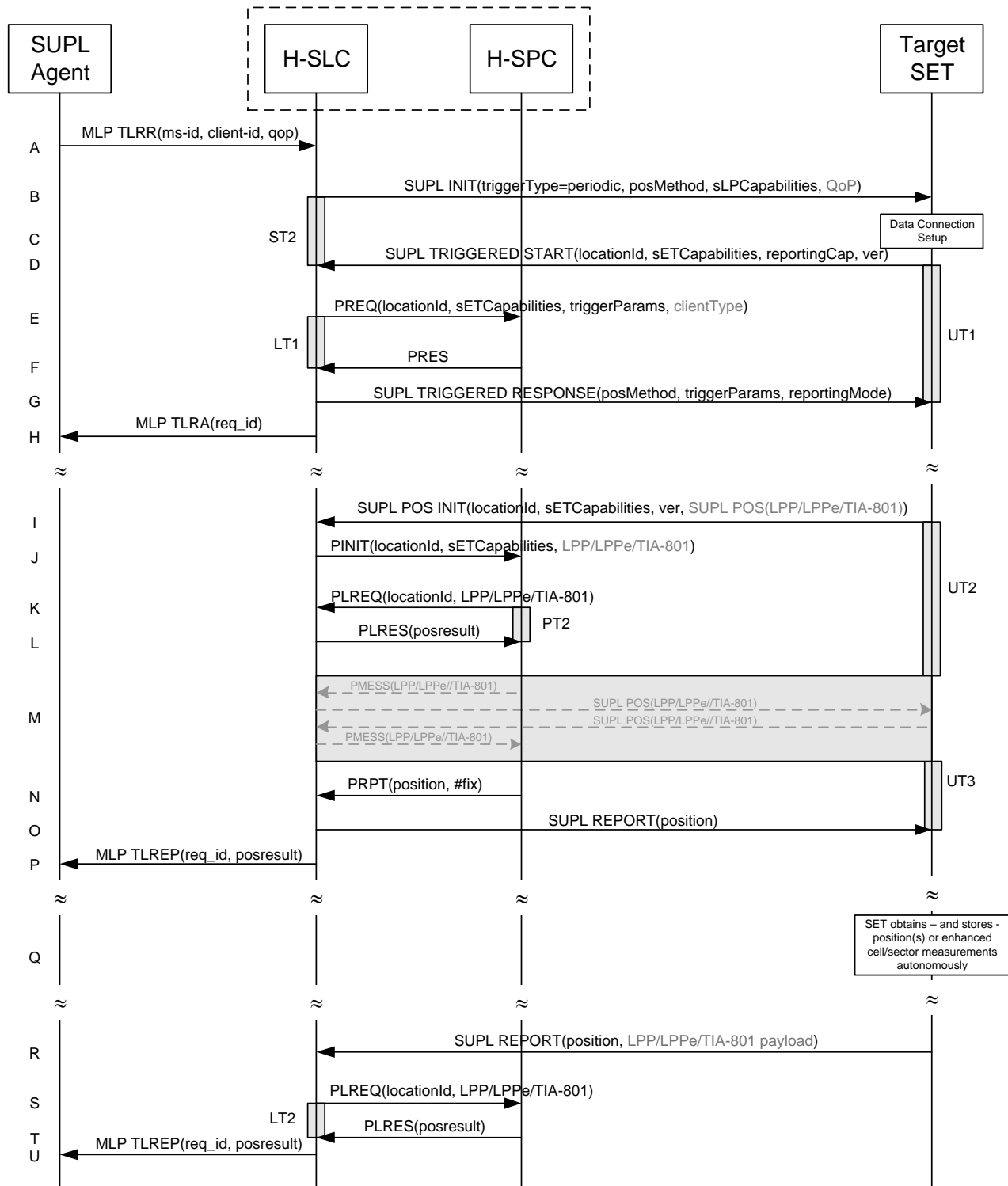


Figure 7: Network Initiated Periodic Trigger (Part I)



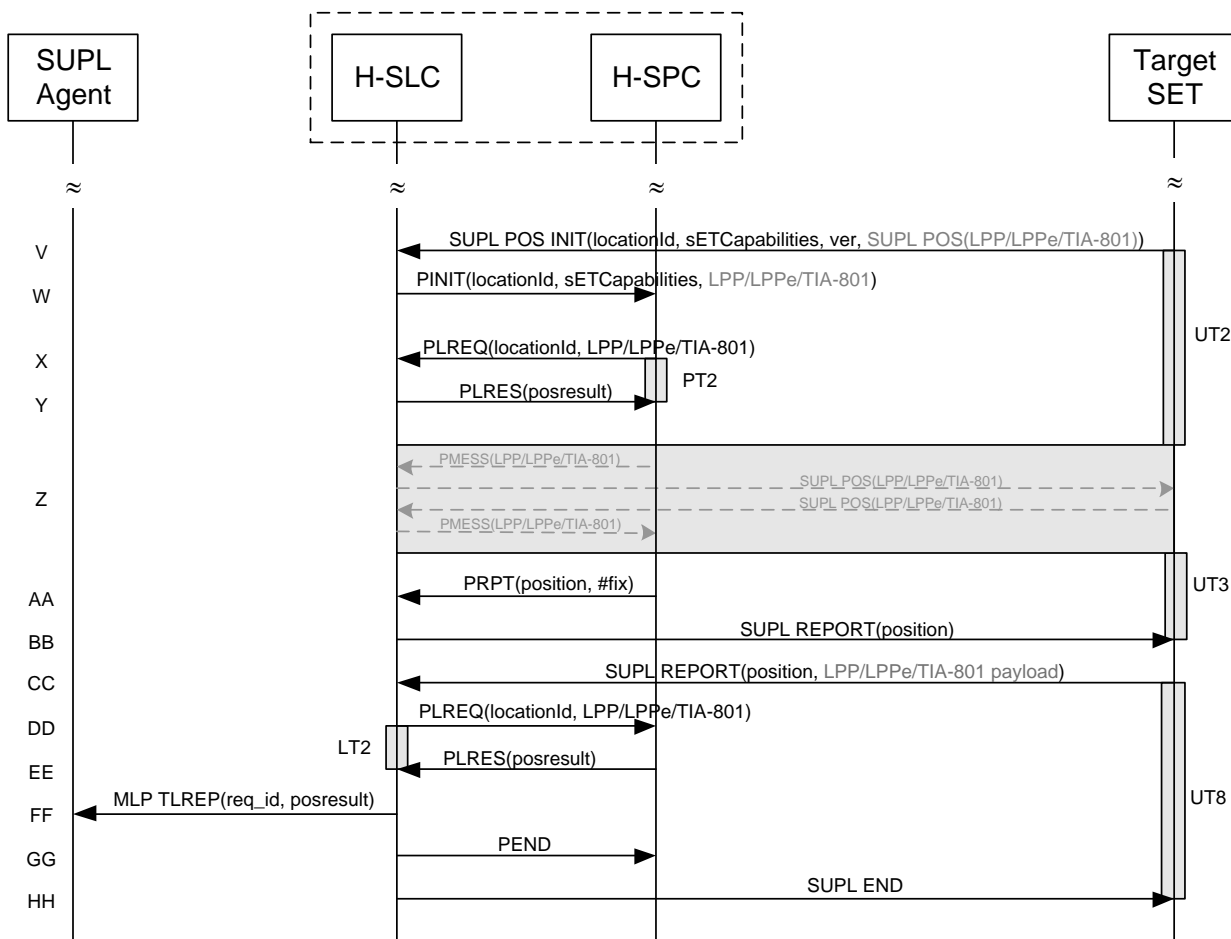


Figure 8: Network Initiated Periodic Trigger (Part II)

- A. The SUPL Agent issues an MLP TLRR message to the H-SLC, with which SUPL Agent is associated. The TLRR message may indicate that batch reporting or quasi-real time reporting is to be used instead of real time reporting.
- B. The H-SLC initiates a periodic trigger session with the SET by sending a SUPL INIT message to the SET. The SUPL INIT message contains the intended positioning method (*posMethod*), the SLP Capabilities (*sLPCapabilities*), trigger type indicator (*triggerType=periodic*) and optionally the desired QoP. If the result of the privacy check in Step A indicates that notification or verification to the target subscriber is needed, the H-SLC SHALL also include the Notification element in the SUPL INIT message. Before the SUPL INIT message is sent, the H-SLC also computes and stores a hash of the SUPL INIT message.
- C. The SET analyses the received SUPL INIT message. If found not to be authentic, the SET takes not further action. Otherwise the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC. The SET also calculates the hash of the received SUPL INIT message.
- D. The SET evaluates the Notification rules and takes appropriate action. The SET SHALL establish a TLS connection to the H-SLC using the H-SLP address provisioned by the Home Network. The SET then sends a SUPL TRIGGERED START message to start a periodic triggered session with the H-SLP. The SET SHALL send the SUPL TRIGGERED START message even if the SET does not support the intended positioning method indicated in SUPL INIT (step B). The SUPL TRIGGERED START message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*), reporting capabilities (*reportingCap*) and the hash of the received SUPL INIT message (*ver*) calculated in step B. The *reportingCap* parameter indicates whether the SET is capable of batch reporting, real time reporting and/or quasi-real time reporting.

- E. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message containing the Location ID (*locationId*), SET capabilities the trigger parameters (*triggerParams*) and optionally the client type (*clientType*). The PREQ MAY also optionally contain the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- F. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- G. The H-SLC SHALL verify that the value of the *ver* parameter received in SUPL TRIGGERED START in step D matches the one calculated and stored by the H-SLC in step B. If the values do not match, the H-SLC SHALL send a SUPL END message with status code '*authSuplinitFailure*'. The H-SLC SHALL send a SUPLTRIGGERED RESPONSE message to the SET. The SUPL TRIGGERED RESPONSE message contains the intended positioning method (*posMethod*) and the trigger parameters (*triggerParams*). If the H-SPC included a list of supported posmethods in step F, the chosen intended positioning method SHALL be aligned with the list of supported posmethods. Consistent with the reporting capabilities of the SET (sent in *reportingCap* in step D), the H-SLC also indicates the reporting mode (*reportingMode*) to be used by the SET: real time reporting, quasi-real time reporting or batch reporting. In the case of batch reporting, the SUPL TRIGGERED RESPONSE message indicates the conditions for sending batch reports to the H-SLC and any criteria, when the conditions for sending arise, for including or excluding particular stored position estimates and/or (if allowed) particular stored enhanced cell/sector/AP measurements. In the case of quasi-real time reporting, the SUPL TRIGGERED RESPONSE message indicates whether the SET is allowed to send enhanced cell/sector/AP measurements in lieu of or in addition to position estimates. If enhanced cell/sector/AP positioning was selected for batch or quasi-real time reporting, the SUPL TRIGGERED RESPONSE message indicates if the SET is permitted to send stored enhanced cell/sector/AP measurements. In this case, if batch reporting was selected, the SET MAY skip steps I to O.
- H. The H-SLC informs the SUPL Agent in an MLP TLRA message that the triggered location response request has been accepted and also includes a req\_id parameter to be used as a transaction id for the entire duration of the periodic triggered session. SET and H-SLC MAY release the TLS connection.

NOTE: [The MLP TLRA may be sent earlier at any time after the H-SLC receives the MLP TLRR.](#)

- I. When the periodic trigger in the SET indicates that a position fix has to be performed or at any time the SET decides it requires assistance data, the SET establishes a TLS connection to the H-SLC. The SET sends a SUPL POS INIT message to the H-SLC. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and optionally a SUPL POS message carrying LPP/LPPE and/or TIA-801 positioning protocol payload in line with the H-SLP's positioning protocol capabilities (indicated in step B in *sLPCCapabilities*). The SET MAY also provide its position, if this is supported.  
If a position calculated based on information received in the SUPL POS INIT message is available (e.g. a cell-id based position fix) that meets the required QoP, the H-SLC MAY directly proceed to step O and not engage in a SUPL POS session.
- J. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step I. The H-SLC MAY include a posmethod in PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step F, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC.  
If a posmethod was included in PINIT, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in PINIT, the H-SPC SHALL choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step E. If required for the posmethod the H-SPC SHALL use the supported positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step N and not engage in a SUPL POS session.
- K. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step J into a position. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.

- L. This step is conditional and only occurs if step K was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step N and not engage in a SUPL POS session.
- M. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- N. Once the position calculation is complete the H-SPC sends a PRPT message including the position result (*position*) to the H-SLC.
- O. Once the position calculation (or assistance data delivery) is complete, the H-SLC sends a SUPL REPORT message to the SET. If the reporting mode is batch reporting, the SET stores all calculated position estimates. In SET Assisted mode the position is calculated by the H-SLP and therefore is included in the SUPL REPORT message for batch reporting mode. The SET MAY release the TLS connection to the H-SLC.

If a SET Based positioning method was chosen which allows the SET to autonomously calculate a position estimate (e.g. autonomous GNSS or A-GNSS SET Based mode where the SET has current GNSS assistance data and does not require an assistance data update from the H-SLP) steps I to O are not performed. Instead, the SET autonomously calculates the position estimate and – for real time or quasi-real time reporting – sends the calculated position estimate to the H-SLC using a SUPL REPORT message containing the the position estimate.

- P. This step is optional: Once the position calculation is complete and if real time or quasi-real time reporting is used, the H-SLC sends a MLP TLREP message including the position result (*posresult*) to the SUPL Agent. If the reporting mode is set to batch reporting, this message is not used.
- Q. This step is optional: If the SET cannot communicate with the H-SLC and quasi-real time reporting is used or if batch reporting is used, the SET MAY – if supported - perform SET Based position fixes (e.g. autonomous GNSS or SET Based A-GNSS where the SET has current assistance data) and/or, if allowed by the H-SLC, enhanced cell/sector/AP measurements. In the case of batch reporting, and if explicitly allowed by the H-SLC, enhanced cell/sector/AP measurements are permitted even when the SET can communicate with the H-SLC.
- R. This step is optional and is executed if batch reporting is used and if any of the conditions for sending batch reports have occurred. It is also executed, once the SET is able to re-establish communication with the H-SLC, if quasi-real time reporting is used if one or more previous reports have been missed. The SET sends the stored position estimates and/or, if allowed, the stored enhanced cell/sector/AP measurements (sent in LPP/LPPE/TIA-801 payload messages) in an unsolicited SUPL REPORT message to the H-SLC. The SUPL REPORT message contains the position result(s) including date and time information for each position result and optionally the position method used. In the case of batch reporting, the stored position estimates and/or enhanced cell/sector/AP measurements included in the SUPL REPORT message may be chosen according to criteria received in step G. If no criteria are received in step G, the SET shall include all stored position estimates and/or enhanced cell/sector/AP measurements not previously reported. If applicable, enhanced cell/sector/AP measurements are sent in LPP/LPPE/TIA-801 payload messages.
- S. This step is optional: if the SUPL REPORT message in step R contained enhanced cell/sector measurements (sent in LPP/LPPE/TIA-801 payload messages) and the H-SPC is required to translate the received enhanced cell/sector measurements into position estimates, the H-SLC sends a PLREQ message containing the Location ID (*locationId*) and enhanced cell/sector measurements sent in LPP/LPPE/TIA-801 payload messages to the H-SPC.
- T. This step is conditional and only used if step S occurred: the H-SPC returns the calculated position estimates to the H-SLC in a PLRES message.
- U. The H-SLC forwards the reported and/or calculated position estimate(s) to the SUPL Agent in an MLP TLREP message.

Steps I to U are repeated as applicable. When the last position estimate needs to be calculated i.e. the end of the periodic triggered session has been reached, steps V to BB may be performed (a repeat of steps I to O). Alternatively - and if applicable - step Q is repeated.

CC. This step is optional. When real-time reporting is used, it is executed after the last position estimate or, if allowed, last set of enhanced cell/sector measurements has been obtained or was due. When batch or quasi real-time reporting is used, step CC is executed if and as soon as the following conditions apply:

- i. The SET has stored historic location reports and/or stored historic enhanced cell/sector measurements that have not yet been sent to the H-SLC.
- ii. The SET is able to establish communication with the H-SLC.
- iii. In the case of batch reporting, the conditions for sending have arisen or the SET has obtained the last fix according to the number of fixes (in which case an incomplete batch of positions is sent).

The SUPL REPORT message is used to send all or a subset of stored position fixes and/or stored enhanced cell/sector measurements (sent in LPP/LPPe/TIA-801 payload messages) not previously reported to the H-SLC. In the case of batch reporting, the stored position estimates and/or stored enhanced cell/sector measurements included in the SUPL REPORT message may be chosen according to criteria received in step G. If no criteria are received in step G, the SET shall include all stored position estimates and/or stored enhanced cell/sector measurements not previously reported.

DD. This step is optional: if the SUPL REPORT message in step CC contained enhanced cell/sector measurements received in the LPP/LPPe/TIA-801 payload message and the H-SPC is required to translate the received enhanced cell/sector measurements into position estimates, the H-SLC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPe/TIA-801 payload to the H-SLC.

EE. This step is conditional and only used if step DD occurred: the H-SPC returns the calculated position estimates to the H-SLC in a PLRES message.

FF. The H-SLC forwards the reported and/or calculated historical position estimate(s) to the SUPL Agent in an MLP TLREP message. As an option (e.g. if the SUPL Agent is not available), the H-SLC could retain the historic position fixes for later retrieval by the SUPL Agent.

GG. After the last position result has been reported to the SUPL Agent in step FF or following some timeout on not receiving stored position estimates in step CC, the H-SLC informs the H-SPC about the end of the periodic triggered session by sending a PEND message.

HH. The H-SLC ends the periodic triggered session by sending a SUPL END message to the SET.

### 5.3.2 Network Initiated Area and Velocity Event Triggers

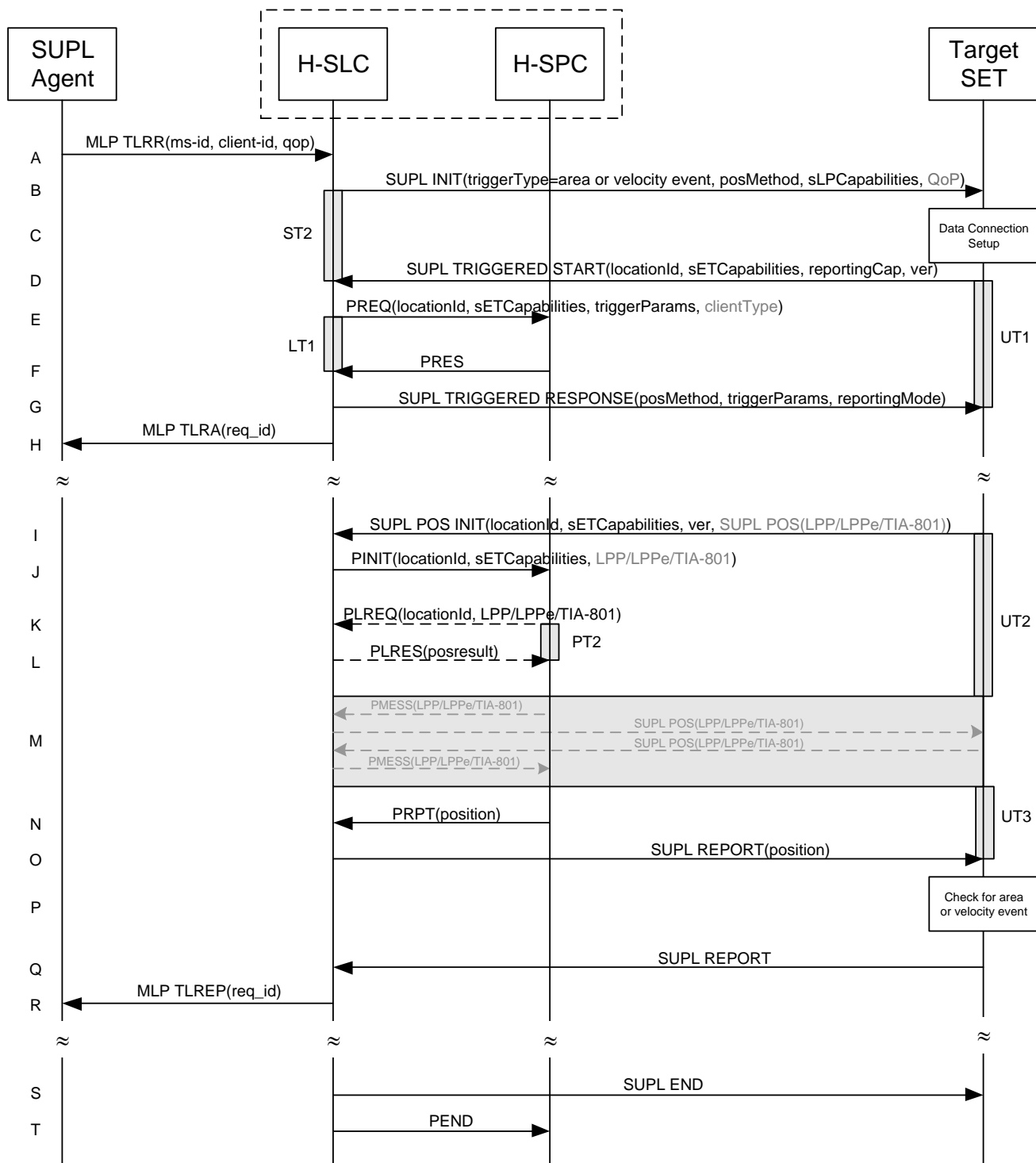


Figure 9: Network Initiated Area or Velocity Event Trigger

NOTE: See Appendix C for timer descriptions.

- A. The SUPL Agent sends an MLP TLRR message to the H-SLC, with which it is associated. In the case of an area event triggered session: The MLP TLRR message contains all parameters required for the area event trigger session

(e.g., geographic target area, trigger criteria, etc.). In the case of a velocity event triggered session: The MLP TLRR message contains all parameters required for the velocity event trigger session (e.g., target velocity, start time, stop time, number of reports, etc.).

- B. The H-SLC initiates an area or velocity event trigger session with the SET by sending a SUPL INIT message to the SET. The SUPL INIT message contains the intended positioning method (*posMethod*), the SLP Capabilities (*sLPCapabilities*), trigger type indicator (*triggerType*=area event or velocity event) and optionally the desired QoP. If the result of the privacy check in Step A indicates that notification or verification to the target subscriber is needed, the H-SLC SHALL also include the Notification element in the SUPL INIT message. Before the SUPL INIT message is sent, the H-SLC also computes and stores a hash of the SUPL INIT message.
- C. The SET analyses the received SUPL INIT message. If found not to be authentic, the SET takes no further action. Otherwise the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC. The SET also calculates the hash of the received SUPL INIT message.
- D. The SET evaluates the Notification rules and takes appropriate action. The SET SHALL establish a TLS connection to the H-SLC using the H-SLP address provisioned by the Home Network. The SET then sends a SUPL TRIGGERED START message to start a triggered area or velocity event session with the H-SLP. The SET SHALL send the SUPL TRIGGERED START message even if the SET does not support the intended positioning method indicated in SUPL INIT (step B). The SUPL TRIGGERED START message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and the hash of the received SUPL INIT message (*ver*) calculated in step B.
- E. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message containing the Location ID (*locationId*), SET capabilities the trigger parameters (*triggerParams*) and optionally the client type (*clientType*). The PREQ MAY also optionally contain the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- F. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- G. The H-SLC SHALL verify that the value of the *ver* parameter received in SUPL TRIGGERED START in step D matches the one calculated and stored by the H-SLC in step B. If the values do not match, the H-SLC SHALL send a SUPL END message with status code '*authSuplinitFailure*'. The H-SLC SHALL send a SUPL TRIGGERED RESPONSE message to the SET. The SUPL TRIGGERED RESPONSE message contains the intended positioning method (*posMethod*) and the trigger parameters (*triggerParams*). If the H-SPC included a list of supported posmethods in step F, the chosen intended positioning method SHALL be aligned with the list of supported posmethods.

In the case of an area event triggered session the SUPL TRIGGERED RESPONSE message may also contain the area ids of the specified area (in *triggerParams*).

- H. The H-SLC informs the SUPL Agent in an MLP TLRA message that the triggered location response request has been accepted and also includes a req\_id parameter to be used as a transaction id for the entire duration of the area or velocity event triggered session. SET and H-SLC MAY release the TLS connection.

NOTE: [The MLP TLRA may be sent earlier at any time after the H-SLC receives the MLP TLRR.](#)

- I. If the area ids are downloaded in step G, the SET SHALL compare the current area id to the downloaded area ids. When the area or velocity event trigger mechanism in the SET or the comparison of the current area id to the downloaded area ids indicates that a position fix is to be executed, the SET establishes a TLS connection with the H-SLC. A TLS connection with the H-SLC is also established by the SET, whenever the area or velocity event trigger in the SET indicates that a position fix has to be performed or at any time the SET decides it requires assistance data. The SET then sends a SUPL POS INIT message to the H-SLC. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and optionally a SUPL POS message carrying LPP/LPpE and/or TIA-801 positioning protocol payload in line with the H-SLP's positioning protocol capabilities (indicated in step B in *sLPCapabilities*). The SET MAY also provide its position, if this is supported. If a position calculated based on information received in the SUPL POS INIT message is available (e.g. a cell-id

based position fix) that meets the required QoP, the H-SLP MAY directly proceed to step O and not engage in a SUPL POS session.

- J. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step I. The H-SLC MAY include a posmethod in PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step F, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC. If a posmethod was included in PINIT by the H-SLC, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in PINIT, the H-SPC SHALL choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step E. If required for the posmethod the H-SPC SHALL use the supported positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step N and not engage in a SUPL POS session.
- K. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step J into a position. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.
- L. This step is conditional and only occurs if step K was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step N and not engage in a SUPL POS session.
- M. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- N. Once the position calculation is complete the H-SPC sends a PRPT message including the position result (*position*) to the H-SLC.
- O. Once the position calculation (or assistance data delivery) is complete, the H-SLC sends a SUPL REPORT message to the SET. The SUPL REPORT message may include the position result (*position*) – which may include the velocity - if the result was calculated at the H-SLP. The SET MAY release the secure connection to the H-SLC.
- P. In the case of an area event triggered session: The SET compares the calculated position estimate with the target area to check if the event trigger condition has been met.
- In the case of a velocity event triggered session: The SET compares the calculated velocity with the target velocity to check if the event trigger condition has been met.
- If no area or velocity event is triggered, the SET SHALL return to step I. If an area or velocity event is triggered, the SET SHALL proceed to step Q.
- Q. In the case of an area event triggered session: The SET sends a SUPL REPORT message including the position estimate to the H-SLC unless the Location Estimate parameter is set to “false” in which case no position estimate is included.
- In the case of a velocity event triggered session: The SET sends a SUPL REPORT message including the velocity to the H-D-SLP unless the Velocity Estimate parameter is set to “false”. Since a velocity estimate is always sent as part of a position estimate, the position estimate is also included.
- R. The H-SLC sends a MLP TLREP message to the SUPL Agent which may include the position result.

If the SUPL Agent has requested several reports and more reports are to be sent, the SET repeats steps I to R or steps I to O depending on whether or not an area or velocity event has occurred. Note that in the latter case, step Q occurs only after the minimum time between reports has elapsed.

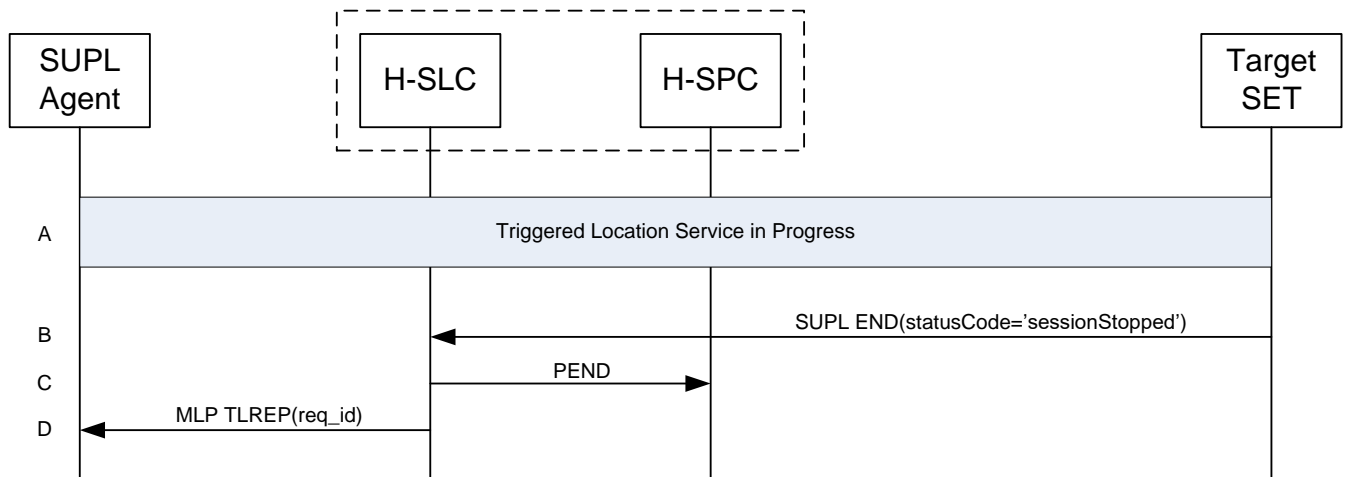
- S. When the maximum number of reports for the SUPL triggered session has been reached, the H-SLC sends a SUPL END message to the SET.

T. The H-SLC informs the H-SPC about the end of the triggered session by sending a PENDING message.

The message flow described in Figure 9 is applicable to all positioning methods; however, individual steps within the message flows are optional:

- Step M (SUPL POS) is not performed for cell-id based positioning methods.
- In SET Based mode where no assistance data is required from the network, no interaction with the H-SLC is required to calculate a position/velocity estimate. Interaction with the H-SLC is only required for assistance data update in which case steps I to O are performed.

When the stop time of the triggered area or velocity event session is reached, the SET initiates the ending of the session as shown in Figure 10.



**Figure 10: Ending of a triggered area or velocity event session when the stop time has been reached.**

- The area or velocity event triggered session is in progress.
- When the StopTime of the event trigger session is reached, the SET sends a SUPL END message with status code “sessionStopped” to the H-SLC.
- The H-SLC informs the H-SPC about the end of the triggered session by sending a PENDING message.
- The H-SLC MAY send an MLP TLREP message to the SUPL Agent to indicate the end of the triggered area or velocity event session.

NOTE: If the SET does not send a SUPL END message within a configured time interval after the Stop Time was reached (i.e. step B did not occur), the H-SLC MAY proceed directly to step C and discard all resources for the session.



### 5.3.3 SET Initiated Triggered Periodic

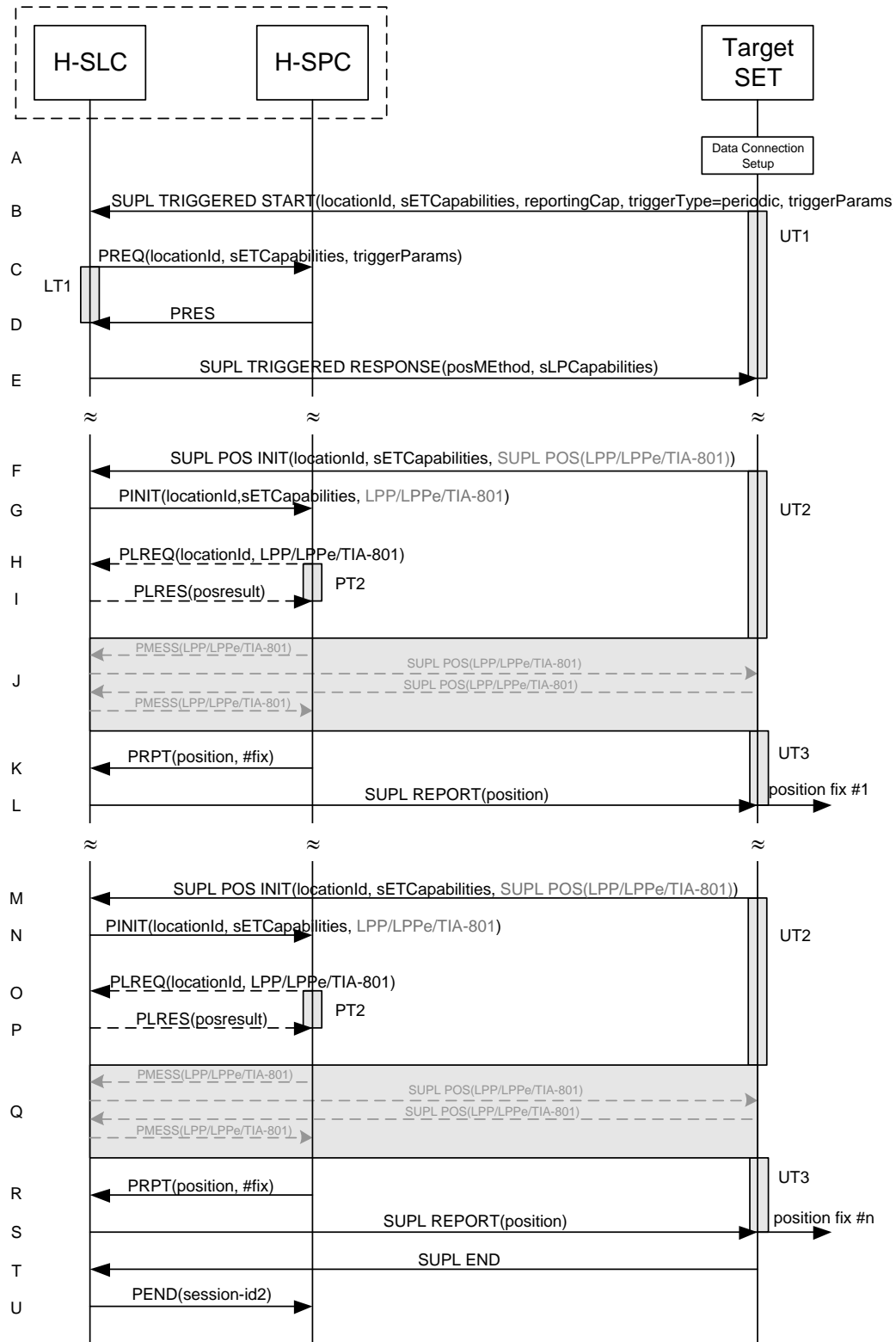


Figure 11: SET Initiated Periodic Trigger

- A. The SUPL Agent on the SET receives a position request from an application running on the SET. The SET takes appropriate action to establish a TLS connection to the H-SLC.
- B. The SUPL Agent on the SET uses the default address provisioned by the Home Network to establish a TLS connection to the H-SLC and sends a SUPL TRIGGERED START message to start a positioning session with the H-SLP. The SUPL TRIGGERED START message contains Location ID (*locationId*), SET capabilities (*sETCapabilities*), trigger type indicator (*triggerType=periodic*), periodic trigger parameters (*triggerParams*) and optionally the QoP.
- C. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message containing the Location ID (*locationId*), SET capabilities and the trigger parameters (*triggerParams*). The PREQ MAY also optionally contain the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- D. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- E. The H-SLC sends a SUPLTRIGGERED RESPONSE message to the SET. The SUPL TRIGGERED RESPONSE message contains the intended positioning method (*posMethod*) and the SLP Capabilities (*sLPCapabilities*). If the H-SPC included a list of supported posmethods in step D, the chosen intended positioning method SHALL be aligned with the list of supported posmethods.
- F. When the periodic trigger in the SET indicates that a position fix has to be performed or at any time the SET decides it requires assistance data, the SET establishes a TLS connection to the H-SLC. The SET sends a SUPL POS INIT message to the H-SLC. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and optionally a SUPL POS message carrying LPP/LPPE and/or TIA-801 positioning protocol payload in line with the H-SLP's positioning protocol capabilities (indicated in step E in *sLPCapabilities*). The SET MAY also provide its position, if this is supported.  
If a position calculated based on information received in the SUPL POS INIT message is available (e.g. a cell-id based position fix) that meets the required QoP, the H-SLC MAY directly proceed to step L and not engage in a SUPL POS session.
- G. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step F. The H-SLC MAY include a posmethod in PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step D, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC.  
If a posmethod was included in PINIT, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in PINIT, the H-SPC SHALL choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step C. If required for the posmethod the H-SPC SHALL use the supported positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- H. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step G into a position. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.
- I. This step is conditional and only occurs if step H was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- J. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).

- K. Once the position calculation is complete the H-SPC sends a PRPT message including the position result (*position*) to the H-SLC.
- L. Once the position calculation (or assistance data delivery) is complete, the H-SLC sends a SUPL REPORT message to the SET. The SUPL REPORT message includes the position result if the position estimate is calculated in the H-SPC and therefore needs to be sent to the SET.

NOTE: Steps F to L are optional and not performed for SET Based mode in the case where no assistance data is required from the network. In this case the SET autonomously calculates a position fix based on the currently available assistance data stored in the SET.

Steps F to L are repeated if so required for calculating any of the remaining position estimates of the periodic triggered session. The last position estimate which – as shown in this case - requires the execution of steps F to L, is shown in steps M to S.

- S. After the last position result has been calculated, the SET ends the periodic triggered session by sending a SUPL END message to the H-SLC.
- T. The H-SLC ends the periodic triggered session with the H-SPC by sending a PEND message.

### 5.3.4 SET Initiated Area and Velocity Event Triggers

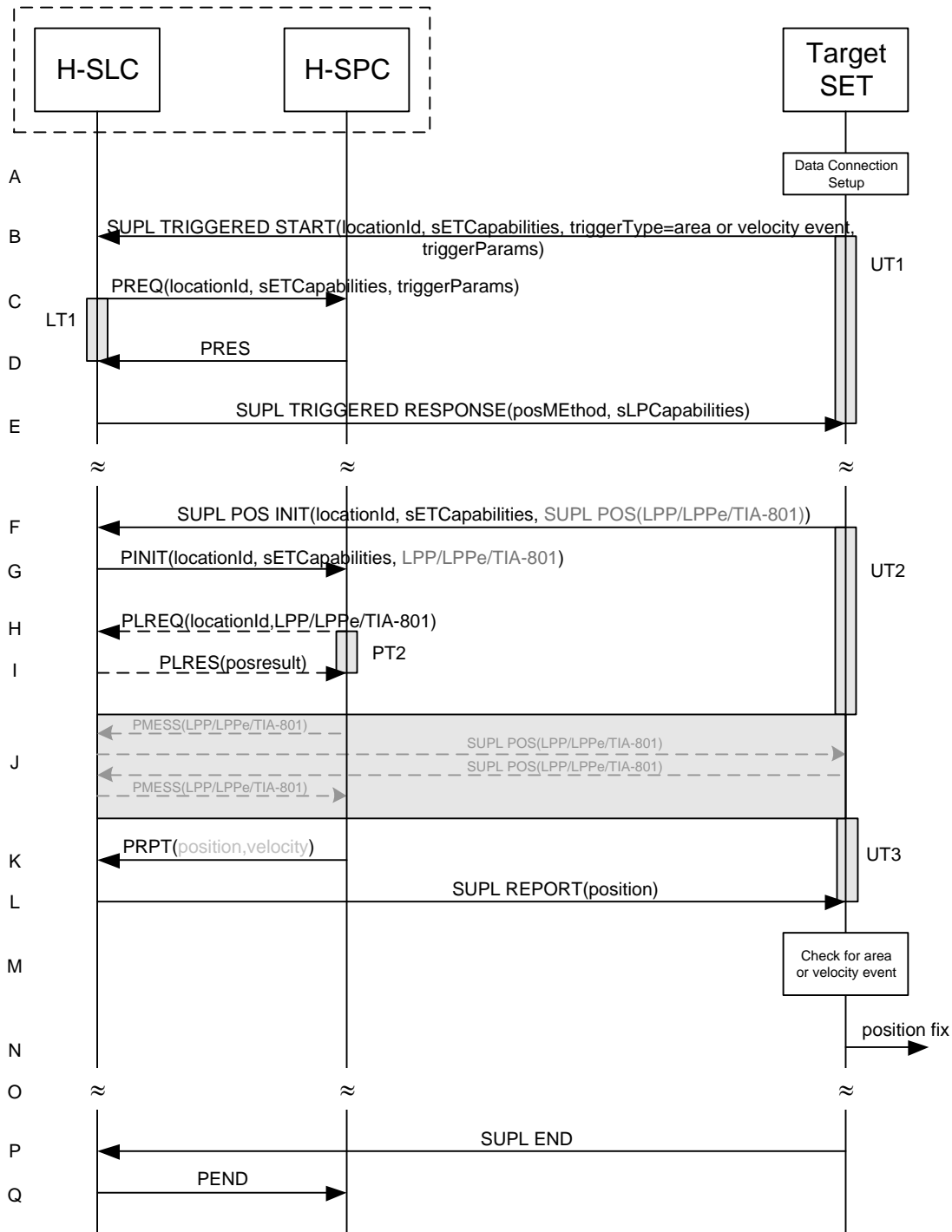


Figure 12: SET Initiated Area or Velocity Event Trigger

- A. The SUPL Agent on the SET receives a position request from an application running on the SET. The SET takes appropriate action to establish a TLS connection to the H-SLC.

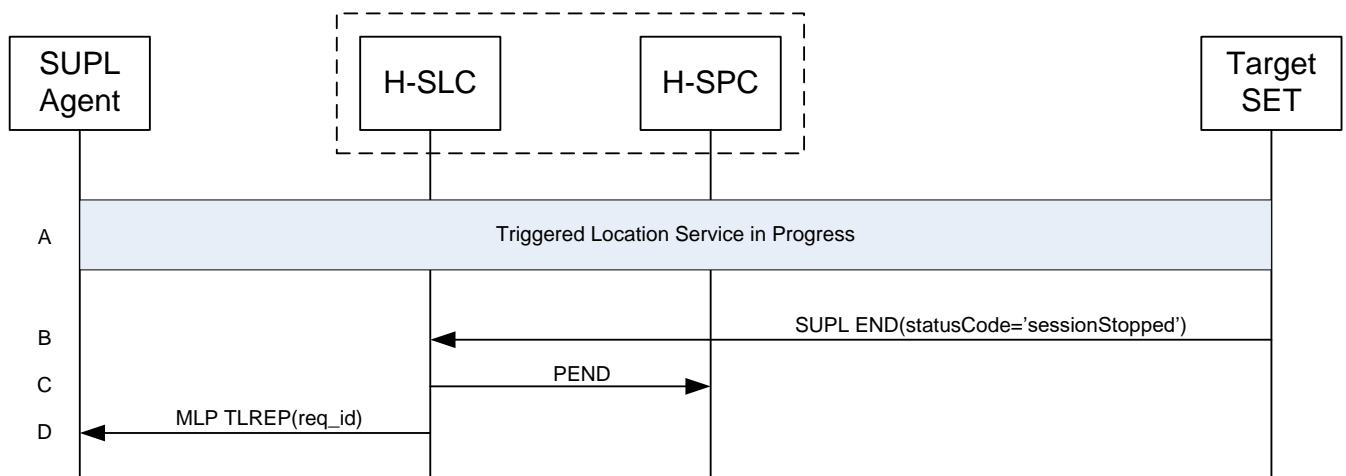
- B. The SUPL Agent on the SET uses the default address provisioned by the Home Network to establish a TLS connection to the H-SLC and sends a SUPL TRIGGERED START message to start a positioning session with the H-SLP. The SUPL TRIGGERED START message contains Location ID (*locationId*), SET capabilities (*sETCapabilities*), trigger type indicator (*triggerType*=area event or velocity event), area or velocity event trigger parameters (*triggerParams*) and optionally the QoP.
- C. The H-SLC requests service from the H-SPC for a SUPL session by sending a PREQ message containing the Location ID (*locationId*), SET capabilities and the trigger parameters (*triggerParams*). The PREQ MAY also optionally contain the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- D. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- E. The H-SLC sends a SUPLTRIGGERED RESPONSE message to the SET. The SUPL TRIGGERED RESPONSE message contains the intended positioning method (*posMethod*) and the SLP Capabilities (*sLPCapabilities*). If the H-SPC included a list of supported posmethods in step D, the chosen intended positioning method SHALL be aligned with the list of supported posmethods.
- F. When the area or velocity event trigger in the SET indicates that a position fix has to be performed or at any time the SET decides it requires assistance data, the SET establishes a TLS connection to the H-SLC. The SET sends a SUPL POS INIT message to the H-SLC. The SUPL POS INIT message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and optionally a SUPL POS message carrying LPP/LPPE and/or TIA-801 positioning protocol payload in line with the H-SLP's positioning protocol capabilities (indicated in step E in *sLPCapabilities*). The SET MAY also provide its position, if this is supported.  
If a position calculated based on information received in the SUPL POS INIT message is available (e.g. a cell-id based position fix) that meets the required QoP, the H-SLC MAY directly proceed to step L and not engage in a SUPL POS session.
- G. The H-SLC sends a PINIT message to the H-SPC including the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and any LPP/LPPE/TIA-801 payload received in step F. The H-SLC MAY include a posmethod in PINIT. This posmethod may either be the posmethod recommended by the H-SPC in step D, or a different posmethod of the H-SLC's choosing, as long as it is one supported by the H-SPC.  
If a posmethod has been included in the PINIT by the H-SLC, the H-SPC SHALL use that posmethod. If no posmethod parameter was included in the PINIT, the H-SPC SHALL choose any posmethod in line with the SET capabilities and which was approved by the H-SLC in step C. If required for the posmethod the H-SPC SHALL use the supported positioning protocol (e.g. LPP, LPPE or TIA-801) from the PINIT message. If a position received from or calculated based on information received in the PINIT message is available that meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- H. This step is optional and only executed if the H-SPC cannot translate information received in the *locationId* or LPP/LPPE/TIA-801 payload received in step G into a position. In this case the H-SPC sends a PLREQ message containing the Location ID (*locationId*) and LPP/LPPE/TIA-801 payload to the H-SLC.
- I. This step is conditional and only occurs if step H was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message. If the position result meets the required QoP, the H-SPC MAY directly proceed to step K and not engage in a SUPL POS session.
- J. SET and H-SPC MAY exchange several successive positioning procedure messages. Thereby the positioning procedure payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).
- K. Once the position calculation – which may include the velocity - is complete the H-SPC sends a PRPT message including the position result (*position*) to the H-SLC.

- L. Once the position calculation (or assistance data delivery) is complete, the H-SLC sends a SUPL REPORT message to the SET. The SUPL REPORT message includes the position result – which may include the velocity - if the position estimate is calculated in the H-SPC and therefore needs to be sent to the SET.
- M. In the case of an area event triggered session: The SET compares the calculated position estimate with the target area to check if the event trigger condition has been met.  
  
In the case of a velocity event triggered session: The SET compares the calculated velocity with the target velocity to check if the event trigger condition has been met.  
  
If no area event or velocity is triggered, the SET SHALL return to step F.
- N. If an area or velocity event was triggered, the SET forwards the calculated position and/or velocity estimate to the internal SUPL Agent.
- O. If the SUPL Agent has requested several reports and more reports are to be sent, the SET repeats step F to M or step F to N depending on whether or not an area or velocity event occurred. Note that in the latter case, step N occurs only after the minimum time between reports has elapsed.
- P. When maximum number of reports for the SUPL triggered session has been reached, the SET sends a SUPL END message to the H-SLC.
- Q. The H-SLC informs the H-SPC about the end of the triggered session by sending a PEND message.

The flow described in Figure 12 is applicable to all positioning methods; however, individual steps within the flows are optional:

- Step J is not performed for cell-id based positioning methods.
- In SET Based mode where no assistance data is required from the network, no interaction with the H-SLC is required to calculate a position estimate. Interaction with the H-SLC is only required for assistance data update in which case steps F to L are performed.

When the stop time of the triggered area or velocity event session is reached, the SET initiates the ending of the session as shown in Figure 13.



**Figure 13: Ending of a triggered area or velocity event session when the stop time has been reached.**

- A. The area or velocity event triggered session is in progress.
- B. When the StopTime of the event trigger session is reached, the SET sends a SUPL END message with status code “sessionStopped” to the H-SLC.

- C. The H-SLC informs the H-SPC about the end of the triggered session by sending a PEND message.
- D. The H-SLC MAY send an MLP TLREP message to the SUPL Agent to indicate the end of the triggered area or velocity event session.

NOTE: If the SET does not send a SUPL END message within a configured time interval after the Stop Time was reached (i.e. step B did not occur), the H-SLC MAY proceed directly to step C and discard all resources for the session.

### 5.3.5 Network Initiated Generic SUPL Session (GSS)

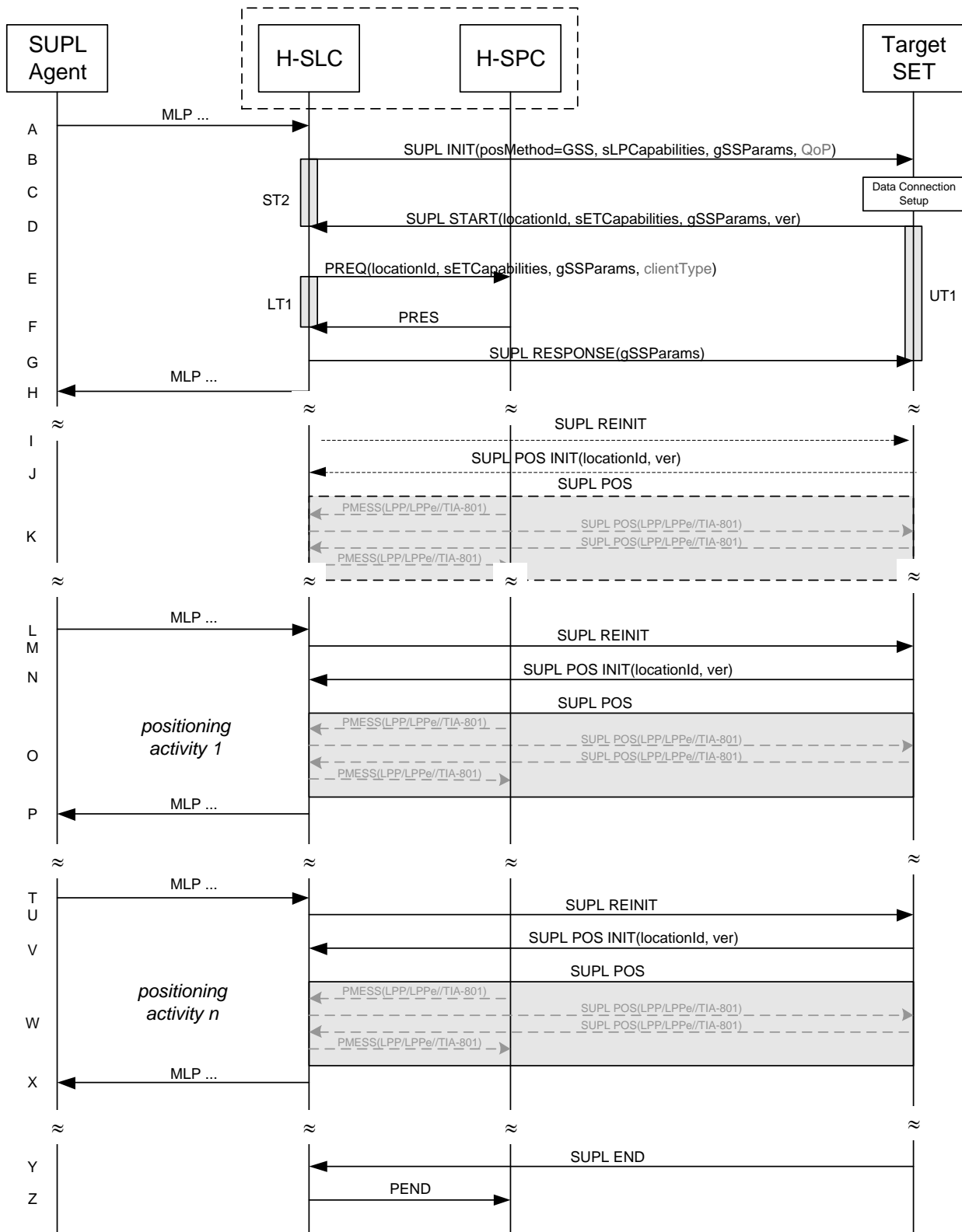


Figure 14: Network Initiated GSS



- A. This step is optional: the SUPL Agent may send an MLP request for location service to the H-SLC, with which it is associated. A GSS may also be established by the H-SLC based on some other event or condition and in the absence of any MLP location requests by the SUPL Agent.
- B. The H-SLC initiates a GSS with the SET by sending a SUPL INIT message. The SUPL INIT message contains a positioning method (*posMethod*) of “GSS”. The H-SLC also includes the SLP Capabilities (*sLPCapabilities*) which are used to indicate the supported positioning protocol (LPP/LPpE or TIA-801) and the GSS Parameter (*gSSParams*). The GSS Parameter defines the desired duration of the GSS. If the result of the privacy check in step A indicates that notification and/or verification of the target subscriber is needed, the H-SLC SHALL also include the Notification parameter in the SUPL INIT message otherwise, the Notification parameter SHALL be omitted. Before the SUPL INIT message is sent, the H-SLC also computes and stores the hash of the SUPL INIT message.
- C. The SET analyses the received SUPL INIT message. If found not to be authentic, the SET takes not further action. Otherwise, the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC. The SET also calculates the hash of the received SUPL INIT message.
- D. The SET evaluates the Notification rules and takes the appropriate action. The SET SHALL establish a TLS connection to the H-SLC using the H-SLP address provisioned by the Home Network. The SET then sends a SUPL START message to the H-SLC. The SUPL START message includes the Location ID (*locationId*), SET Capabilities (*sETCapabilities*), GSS Parameter (*gSSParams*) and the hash (*ver*) of the received SUPL INIT message. The SET Capabilities are used to indicate to the H-SLC which positioning protocol(s) is/are supported by the SET. The GSS Parameter is used to indicate to the H-SLC which duration of GSS the SET is willing and able to support. The H-SLC SHALL verify that the value of the *ver* parameter received in SUPL START matches the one calculated and stored by the H-SLC in step B. If the values do not match, the H-SLC SHALL abort the GSS and send a SUPL END message to the SET with status code ‘*authSuplinitFailure*’.
- E. The H-SLC requests service from the H-SPC by sending a PREQ message containing the Location ID (*locationId*), SET capabilities the trigger parameters (*triggerParams*), the GSS parameters (*gSSParams*) and optionally the client type (*clientType*). The PREQ MAY also optionally contain the QoP. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- F. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- G. The H-SLC sends a SUPL RESPONSE message to the SET including the GSS Parameter. In line with the GSS Parameter exchange in steps B and D, the GSS Parameter is used to determine the final duration of the GSS.
- H. This step is optional and may be performed by the H-SLC to acknowledge the MLP location request by the SUPL Agent in step A, if step A was performed.

The GSS is now established with a pre-defined lifetime (*duration*). The H-SLC may at any time request a position activity such as assistance data provisioning, measurement and/or position request, etc. based on some condition or event. This is shown in the remainder of the call flow.

Steps I, J and K are optional and should be performed by the SET and the SLP in order to exchange their positioning capabilities unless both entities already know each other’s positioning capabilities. The capabilities exchange may be initiated either by the D/H-SLP or the SET. In the case of the D/H-SLP, the D/H-SLP SHALL send a SUPL REINIT as in step I. In the case of the SET, the SET SHALL send a SUPL POS INIT as in step J and step I is omitted.

- I. The D/H-SLP SHALL send a SUPL REINIT message to the SET if the capabilities exchange is initiated by the D/H-SLP. The SUPL REINIT message SHALL contain the same session id as that of the GSS. Before the SUPL REINIT message is sent, the D/H-SLP computes and stores the hash of the SUPL REINIT message.
- J. The SET analyses the received SUPL REINIT message if received. If found not to be authentic, the SET takes not further action. Otherwise, the SET takes required action to prepare for the establishment of a TLS connection with the D/H-SLP if it is not already established. The SET also calculates the hash of the received SUPL REINIT message. The SET SHALL send a SUPL POS INIT message to the D/H-SLP including the Location ID (*locationId*) and hash of the SUPL REINIT message (*ver*).

- K. The positioning capabilities exchanged in this step are those which the SET and the H-SLP are willing and able to use for the GSS. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages and is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).

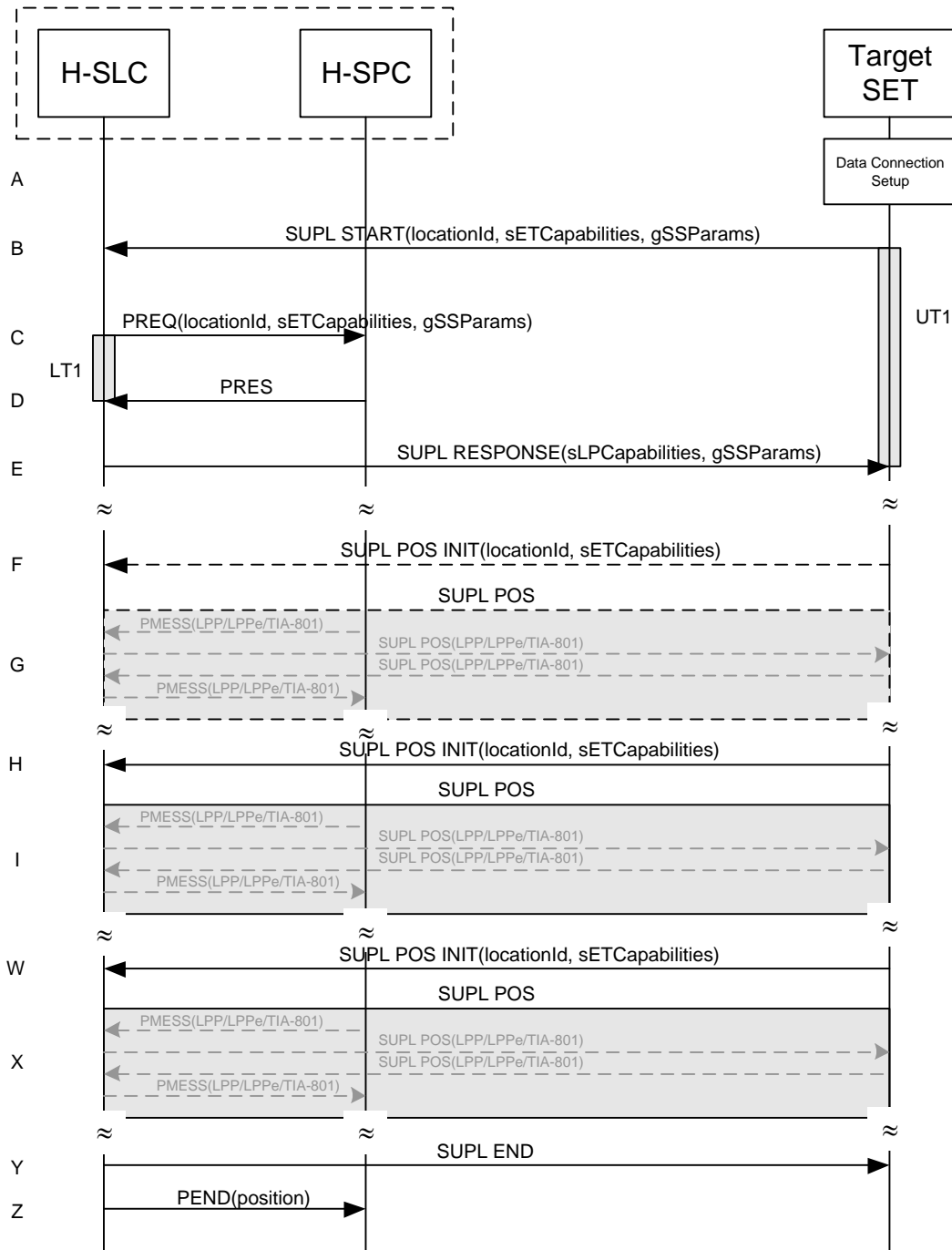
If the exchange of positioning capabilities reveals that no suitable match exists, the H-SLC ends the GSS by sending a SUPL END message to the SET with status code '*gssCapabilityMismatch*'. The SET and the D/H-SLP MAY release the secure connection after positioning capabilities exchange is complete.

- L. This step is optional: a SUPL Agent (which may or may not be the same as the SUPL Agent of step A) sends an MLP request for location service to the H-SLC. This step is only shown as an example to illustrate that an MLP location service request may lead to a positioning activity.
- M. When the H-SLC decides to initiate a positioning activity (which may be the result of step L or some other condition or event), the H-SLC SHALL send a SUPL REINIT message to the SET. Before the SUPL REINIT message is sent, the H-SLC computes and stores the hash of the SUPL REINIT message.
- N. The SET analyses the received SUPL REINIT message. If found not to be authentic, the SET takes no further action. Otherwise, the SET takes required action to prepare for the establishment of a TLS connection with the H-SLC if it is not already established. The SET also calculates the hash of the received SUPL REINIT message. The SET SHALL send a SUPL POS INIT message to the H-SLC including the Location ID (*locationId*) and hash of the SUPL REINIT message (*ver*).
- O. SET and H-SPC MAY exchange SUPL POS messages to execute the requested positioning activity. Initial SUPL POS messages may be used if needed to provide the H-SLC with the access network type for the SET which may then be used to select the most appropriate positioning protocol (LPP/LPPE or TIA-801) and positioning methods. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different). The SET and the D/H-SLP MAY release the secure connection after positioning activity is complete.
- P. This step is optional and may be performed by the H-SLC to provide a response to the SUPL Agent's request for location service and may include the results of the positioning activity in step L – if step L took place.

Steps L to P may be repeated as required and at any time during the lifetime of the GSS (this is illustrated in steps T to X).

- Y. When the end of the GSS is reached, the SET sends a SUPL END message to the H-SLC.
- Z. The H-SLC informs the H-SPC about the end of the session by sending a PEND message.

### 5.3.6 SET Initiated Generic SUPL Session (GSS)

- A. The SUPL Agent on the SET requests the establishment of a GSS. The SET takes appropriate action to establish a TLS connection to the H-SLC.
- B. The SET uses the default address provisioned by the Home Network to establish a TLS connection to the H-SLC and sends a SUPL START message to start a GSS with the H-SLP. The SUPL START message contains the Location ID (*locationId*), SET capabilities (*sETCapabilities*) and GSS Parameters (*gSSParams*). The SET

Capabilities are used to indicate to the H-SLC which positioning protocols are supported by the SET (LPP/LPPE or TIA-801). The GSS Parameter is used to indicate the desired duration of the GSS.

- C. The H-SLC requests service from the H-SPC by sending a PREQ message containing the Location ID (*locationId*), SET capabilities the trigger parameters (*triggerParams*), the GSS parameters (*gSSParams*) and optionally the client type (*clientType*). The PREQ MAY also optionally contain the QoS. The H-SLC MAY include its approved positioning methods for this session. If the approved positioning methods are not included, the H-SPC SHALL assume that all its available positioning methods have been approved.
- D. The H-SPC accepts the service request by sending a PRES message to the H-SLC. The H-SPC MAY include a preferred positioning method in PRES and MAY also include its supported positioning methods.
- E. The H-SLC sends a SUPL RESPONSE message to the SET including the SLP Capabilities and the GSS Parameter. In line with the GSS Parameter exchanged in step B, the GSS Parameter in this step is used to determine the final duration of the GSS.

The GSS is now established with a pre-defined lifetime (*duration*). The SUPL Agent which initiated the GSS may at any time request a position activity such as assistance data provisioning, measurement and/or position request, etc. This is shown in the remainder of the call flow.

Steps F and G are optional and should be performed by the SET and the SLP in order to exchange their positioning capabilities unless both entities already know each other's positioning capabilities. The D/H-SLP may also initiate the set capabilities exchange as shown in Figure 14 steps I, J, and K.

- F. The SET sends a SUPL POS INIT message to start a positioning session with the H-SLP to exchange their positioning capabilities.
- G. The positioning capabilities exchanged in this step are those which the SET and the H-SLP are willing and able to use for the GSS. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages and is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).

If the exchange of positioning capabilities reveals that no suitable match exists, the H-SLC ends the GSS by sending a SUPL END message to the SET with status code '*gssCapabilityMismatch*'. The SET and the D/H-SLP MAY release the secure connection after positioning capabilities exchange is complete.

- H. When the SET decides to initiate a positioning activity, the SET establishes a secure connection to the D/H-SLP if it is not already established and then sends a SUPL POS INIT message to start a positioning session with the D/H-SLP.
- I. The SET and the H-SPC MAY exchange SUPL POS messages to execute a requested positioning activity. Initial SUPL POS messages may be used if needed to provide the H-SLC with the access network type for the SET which may then be used to select the most appropriate positioning protocol (LPP/LPPE or TIA-801) and positioning methods. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SPC and the H-SLC using PMESS messages. The positioning protocol payload (LPP/LPPE/TIA-801) is transferred between the H-SLC and the SET using SUPL POS messages (the PMESS – SUPL POS – SUPL POS – PMESS message exchange is shown conceptually in dotted lines but the actual message exchange may be different).

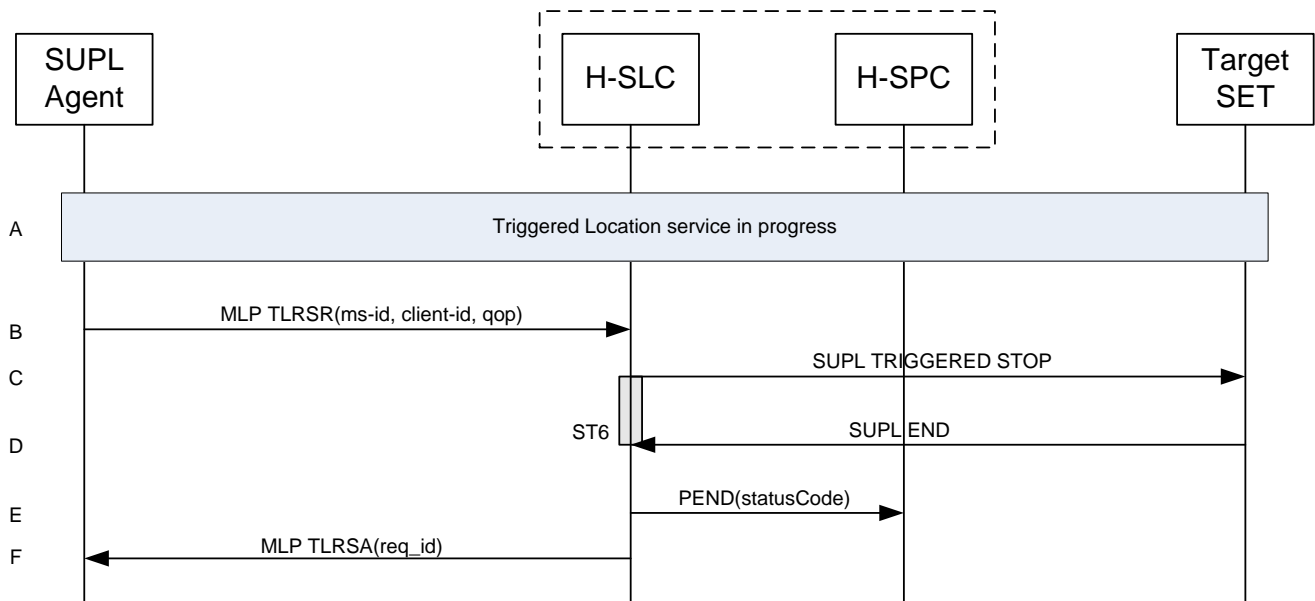
Step H and I may be repeated as required and at any time during the lifetime of the GSS (this is illustrated in steps W and X).

- Y. When the end of the GSS is reached, the H-SLC sends a SUPL END message to the SET.
- Z. The H-SLC informs the H-SPC about the end of the session by sending a PEND message.

### 5.3.7 Exception Procedures

This section describes the exception procedures for triggered scenarios.

### 5.3.7.1 Network cancels the triggered location request

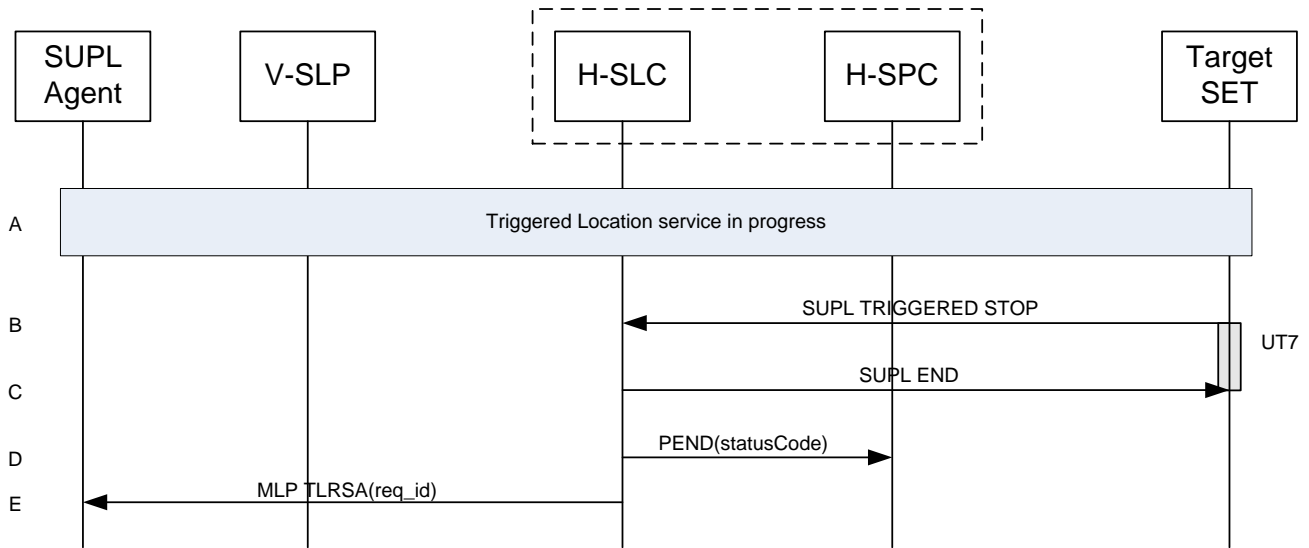


**Figure 16: Network Initiated Triggered location, Network cancels the triggered location request**

NOTE: See Appendix C for timer descriptions.

- A. A triggered location session is in progress.
- B. The SUPL Agent sends a MLP TLRSR message to cancel the ongoing triggered session.  
 NOTE: The MLP TLRSR in this flow is only used to illustrate a possible triggered session cancellation initiated by the SUPL Agent. The triggered session could also be cancelled by the H-SLC i.e. without the SUPL Agent's involvement.
- C. The H-SLC sends a SUPL TRIGGERED STOP message to the target SET to request cancellation of the triggered session.
- D. The target SET acknowledges that it has cancelled the positioning procedure by sending a SUPL END message to the H-SLC.
- E. The H-SLC cancels the triggered session with the H-SPC by sending a PEND message including the appropriate Status Code.
- F. The H-SLC confirms cancellation of the triggered SUPL session by sending a MLP TLRSA message to the SUPL Agent.

### 5.3.7.2 SET cancels the triggered location request

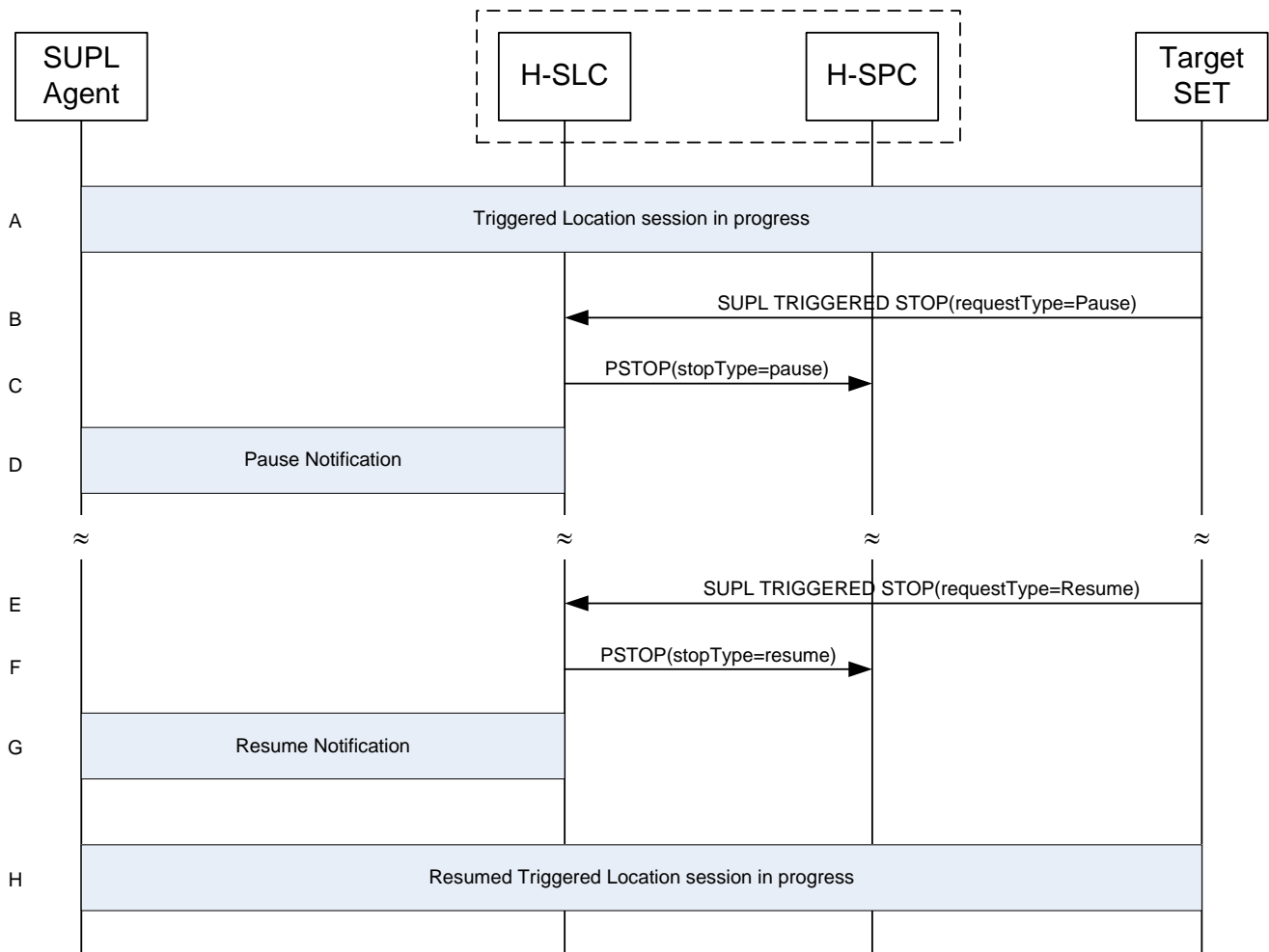


**Figure 17: Network Initiated Triggered location, SET cancels the triggered location request**

- A. A triggered location session is in progress.
- B. The SET sends a SUPL TRIGGERED STOP message including the session-id to the H-SLC to request cancellation of the triggered session.
- C. The H-SLC sends a SUPL END message to the SET to end the session.
- D. The H-SLC cancels the triggered session with the H-SPC by sending a PEND message including the appropriate Status Code.
- E. The H-SLC sends an MLP TLRSA message to the SUPL Agent to inform the SUPL Agent that the triggered session has been cancelled.

### 5.3.7.3 Triggered Session Pause/Resume Procedure – Network Initiated

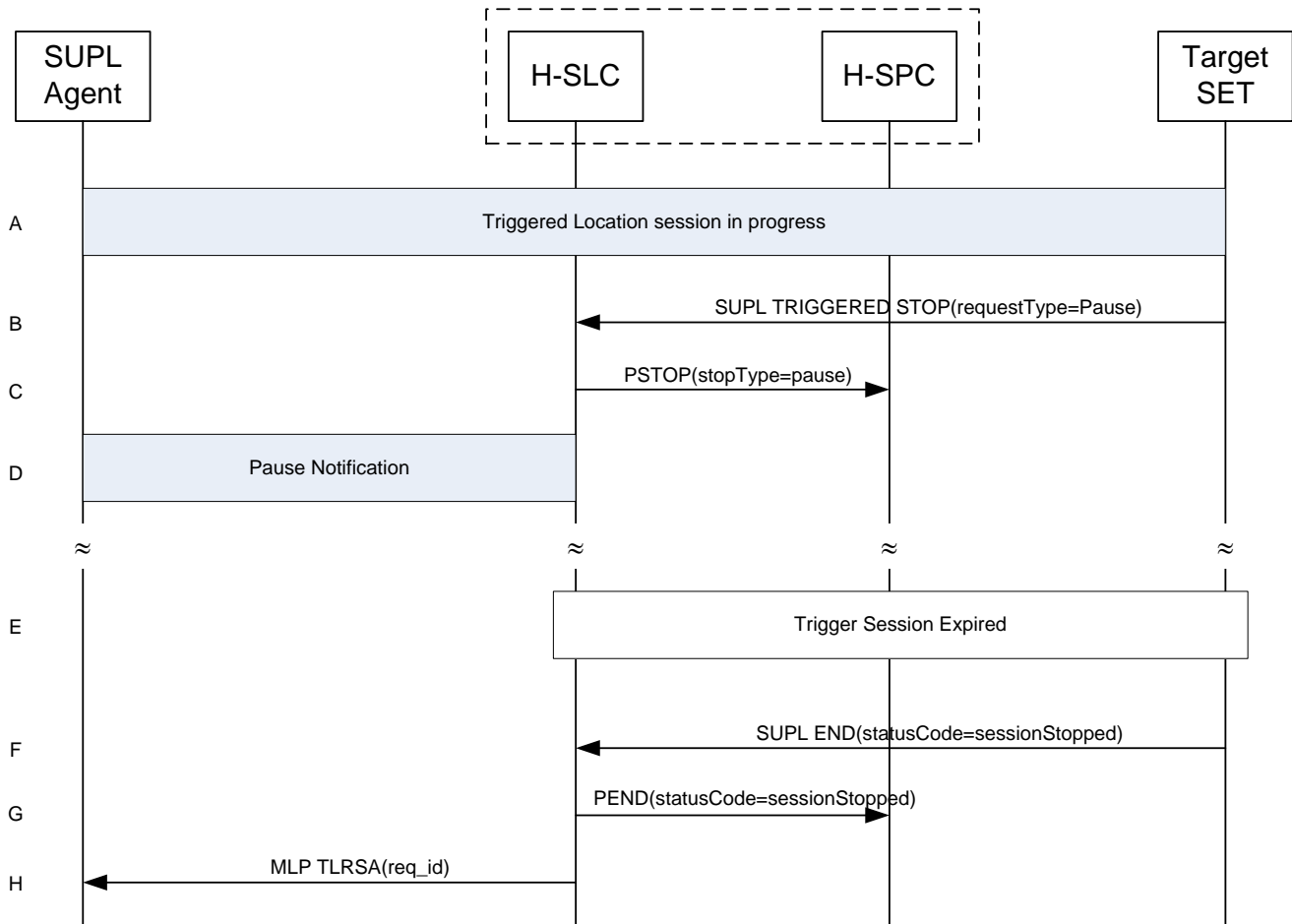


**Figure 18: Network Initiated Triggered Session Pause/Resume Procedure Successful Case**

- A. A triggered session is in progress.
- B. The SET decides to pause the triggered session and sends a SUPL TRIGGERED STOP message with request type “pause” to inform the H-SLP that the triggered session is to be paused. While the triggered session is paused, both triggered sessions in the H-SLP and the SET SHALL still be active, however, the SET SHALL not perform positioning and/or store enhanced cell/section measurements. In case of an area event triggered session, the SET SHALL also not perform Area ID comparisons.
- C. The H-SLC sends a PSTOP message to the H-SPC with stop type “pause” to inform the H-SPC that the triggered session has been paused.
- D. This step is optional. The H-SLC informs the SUPL Agent that the triggered session is paused.
- E. When the SET decides to resume the triggered session, it sends a SUPL TRIGGERED STOP message with request type “resume” to inform the H-SLP that the triggered session in the SET is resumed. SET and H-SLP resume the triggered session.
- F. The H-SLC sends a PSTOP message to the H-SPC with stop type “resume” to inform the H-SPC that the triggered session has been resumed.
- G. This step is optional. The H-SLC informs the SUPL Agent that the triggered session is resumed.

H. The triggered session continues.

### 5.3.7.4 Triggered Session Expires while the Triggered Session is Paused – Network Initiated

- A. A triggered session is in progress.
- B. The SET decides to pause the triggered session and sends a SUPL TRIGGERED STOP message with request type “pause” to inform the H-SLP that the triggered session in the SET is paused. While the triggered session is paused, both triggered sessions in the H-SLP and the SET SHALL be still active, however the SET SHALL not perform positioning and/or store enhanced cell/section measurements. In case of an area event triggered service, the SET SHALL also not perform Area ID comparisons.
- C. The H-SLC sends a PSTOP message to the H-SPC with stop type “pause” to inform the H-SPC that the triggered session has been paused.
- D. This step is optional. The H-SLP informs the SUPL Agent that the triggered session is paused.
- E. While the triggered session is paused, the stop time of the triggered session is reached.

NOTE: In case of a periodic triggered service, the stop time is defined by the number of fixes, the interval between fixes and the start time.

- F. The target SET sends a SUPL END message to the H-SLP including the status code “sessionStopped”.



- G. The H-SLC sends a PEND message to the H-SPC with status code “sessionStopped” to inform the H-SPC that the triggered session has been stopped.
- H. The H-SLC sends an MLP TLRSA message to the SUPL Agent to report that the triggered session has been stopped.

### 5.3.7.5 Triggered Session Pause/Resume Procedure – SET Initiated

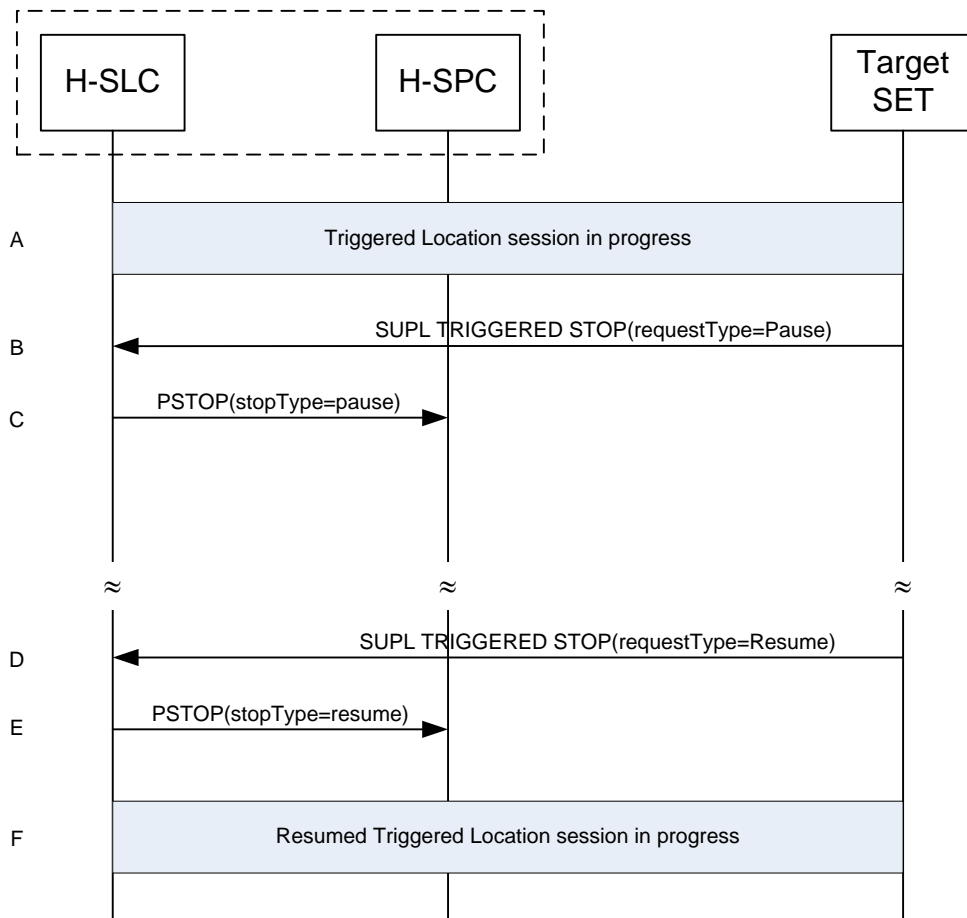
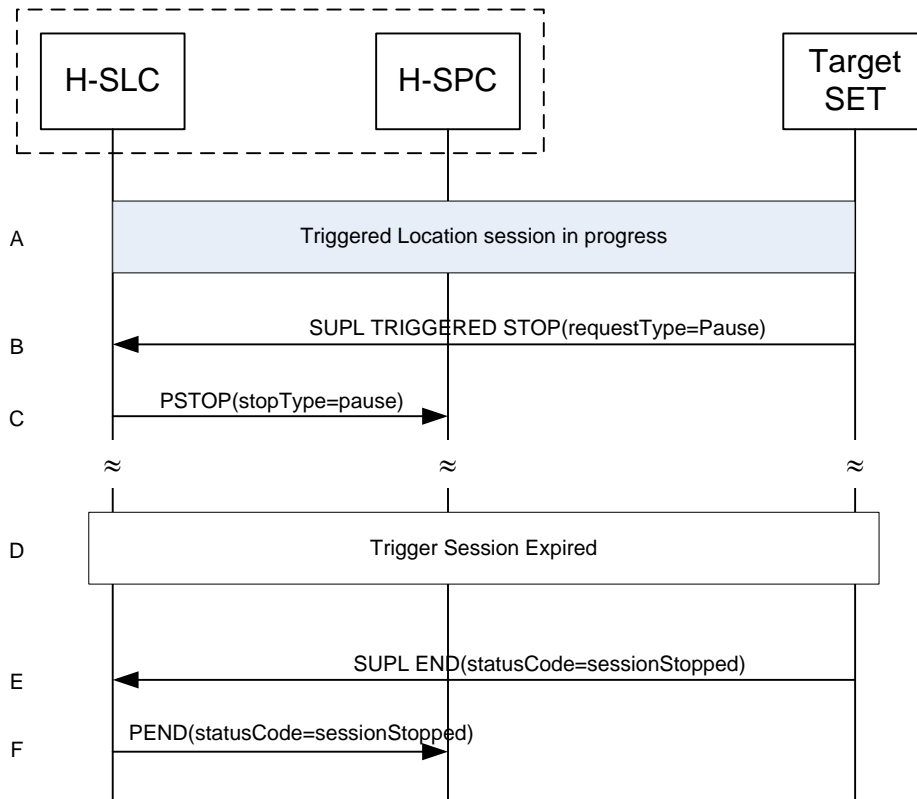


Figure 20: SET Initiated Triggered Session Pause/Resume Procedure Successful Case

- A. A triggered session is in progress.
- B. The SET decides to pause the triggered session and sends a SUPL TRIGGERED STOP message with request type “pause” to inform the H-SLP that the triggered session in the SET is paused. While the triggered session is paused, both triggered sessions in the H-SLP and the SET SHALL be still active, however the SET SHALL not perform positioning and/or store enhanced cell/section measurements. In case of an area event triggered service, the SET SHALL also not perform Area ID comparisons.
- C. The H-SLC sends a PSTOP message to the H-SPC with stop type “pause” to inform the H-SPC that the triggered session has been paused.

**Figure 21: SET Initiated Triggered Session, triggered session expires while the triggered session is paused**

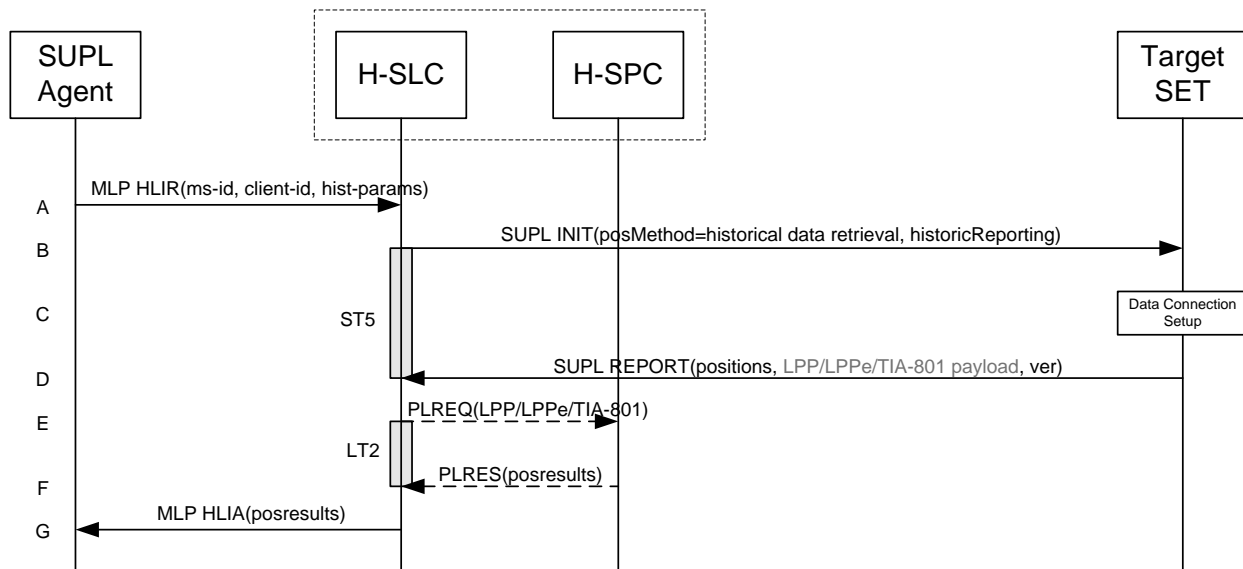
- A. A triggered session is ongoing.
- B. The SET decides to pause the triggered session and sends a SUPL TRIGGERED STOP message with request type “pause” to inform the H-SLP that the triggered session in the SET is paused. While the triggered session is paused, both triggered sessions in the H-SLP and the SET SHALL be still active, however the SET SHALL not perform positioning and/or store enhanced cell/section measurements. In case of an area event triggered service, the SET SHALL also not perform Area ID comparisons.
- C. The H-SLC sends a PSTOP message to the H-SPC with stop type “pause” to inform the H-SPC that the triggered session has been paused.
- D. While the triggered session is paused, the stop time of the triggered session is reached.

- E. The target SET sends a SUPL END message to the H-SLP including the status code “sessionStopped”.

## 5.3.8 Retrieval of Historical Positions and/or Enhanced Cell Sector Measurements

### 5.3.8.1 Retrieval of Historical Position Results



**Figure 22: Retrieval of historical positions and/or enhanced cell/sector measurements**

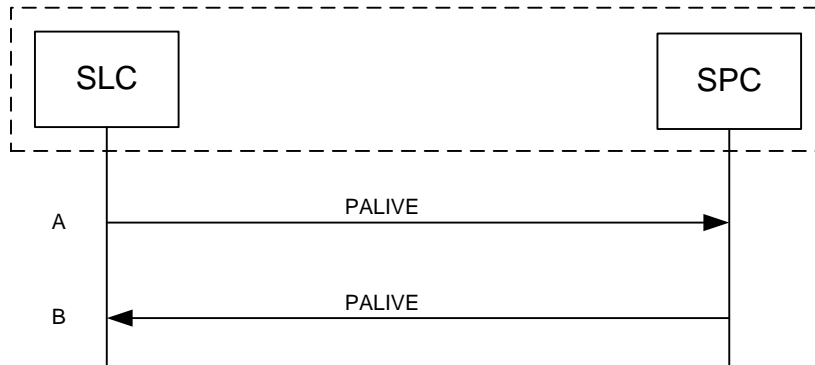
NOTE: See Appendix C for timer descriptions.

- A. The SUPL Agent issues an MLP HLIR message to the H-SLC, with which SUPL Agent is associated. The hist-params parameter in the HLIR message defines criteria to be applied by the SET when selecting historical position to be reported to the SUPL Agent (e.g. time window, QoP, positioning method, etc.).
- B. The H-SLC initiates the retrieval of historic positions with the SET by sending a SUPL INIT message. The SUPL INIT message contains the posMethod and criteria for selecting stored historic position estimates and/or stored enhanced cell/sector measurements (historicReporting). Historic data retrieval is indicated by a positioning method parameter of “*historical data retrieval*”. If the result of the privacy check in Step A indicates that notification or verification to the target subscriber is needed, the H-SLC SHALL also include the Notification element in the SUPL INIT message. Before the SUPL INIT message is sent, the H-SLC also computes and stores a hash of the message.
- C. The SET analyses the received SUPL INIT. If it is found to be non authentic, the SET takes no further action. Otherwise the SET takes needed action preparing for establishment or resumption of a TLS connection with the H-SLC.
- D. The SET evaluates the Notification rules and takes appropriate action. The SET then establishes a TLS connection to the H-SLC using an H-SLP address provisioned by the Home Network. The SET selects historic position estimates and/or historic enhanced cell/sector measurements (sent in LPP/LPPE/TIA-801 payload messages) based on the criteria received in step B and sends the positions and/or enhanced cell/sector measurements in a SUPL REPORT message to the H-SLC. The SUPL REPORT message also contains the hash of the received SUPL INIT message (*ver*).
- E. This step is optional and only executed if the H-SPC cannot translate information received in the LPP/LPPE/TIA-801 payload received in step D into a position. In this case the H-SPC sends a PLREQ message containing the LPP/LPPE/TIA-801 payload to the H-SLC.
- F. This step is conditional and only occurs if step E was performed. The H-SLC reports the position result back to the H-SPC in a PLRES message.
- G. The H-SLC reports the historical position estimates to the SUPL Agent in an MLP HLIA message.

## 5.4 Other

### 5.4.1 SLC/SPC Heartbeat

#### 5.4.1.1 Successful PALIVE exchange



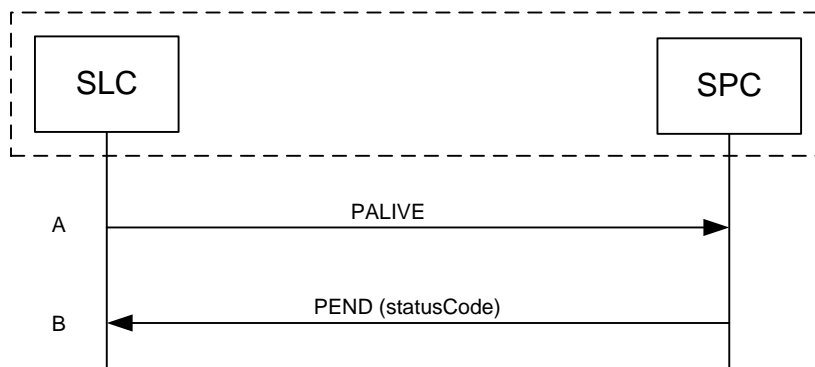
**Figure 23: Successful PALIVE exchange**

NOTE: The use of guard timers for the PALIVE exchange is considered implementation dependent and out of scope for ILP.

- A. The SLC sends a PALIVE message to the SPC.
- B. If the SPC cannot decode the incoming PALIVE message, or if it contains a protocol error or is a version of ILP that the SPC does not support, the SPC SHALL respond with a PEND with an appropriate Status Code.

## 6. Security Considerations

This section describes the security considerations of ILP.

### 6.1 SLC-SPC Security

The connection between the SLC and SPC SHALL be secure. The specifics of which methods are used to secure the connection are beyond the scope of this document.

## 7. Protocols and Interfaces

The encoding for the ILP protocol SHALL be ASN.1 [ASN.1].

The encoding is BASIC-PER, unaligned encoding [PER].

The transport protocol between SLC and SPC SHALL be TCP/IP.

### 7.1 TCP/IP

An Llp reference point MAY provide two socket ports for operation, one for encryption with TLS 1.1 [TLS] and one without.

The port numbers for ILP messages transported over TCP SHALL be as registered with IANA (Internet Assigned Numbers Authority). The port numbers are:

oma-ilp	7276/tcp	OMA Internal Location Protocol
oma-ilp-s	7277/tcp	OMA Internal Location Secure Protocol

NOTE: An SLC or SPC MAY choose to introduce other technologies for secure transfer. Any such technology SHALL be provided over a different port than the two mentioned above.

### 7.2 Llp

The function of the Llp reference point is logically separated into Positioning Control and Positioning Data.

### 7.3 Positioning Control

The Positioning Control interface is used in the establishment, maintenance and clearing of sessions between the SLC and SPC. It enables the SLC and SPC to perform Position Calculation Function.

Table 1 shows the messages of the Llp Positioning Control interface.

## 7.4 Positioning Data

The Positioning Data interface is used to transport information used for the position calculation. This interface is used in proxy mode only.
