The NGSI_Common Part extends Parlay-X Common (Part 1). The XSD file and WSDL files from Parlay-X Part 1 are used as basis for the extended data files.

To ensure consistency for the usage of the extended Parlay X Part 1 interface and to respect the references between the interfaces and the related XSD, this specification provides all updated WSDL and XSD files.

4.1 Version 1.0
